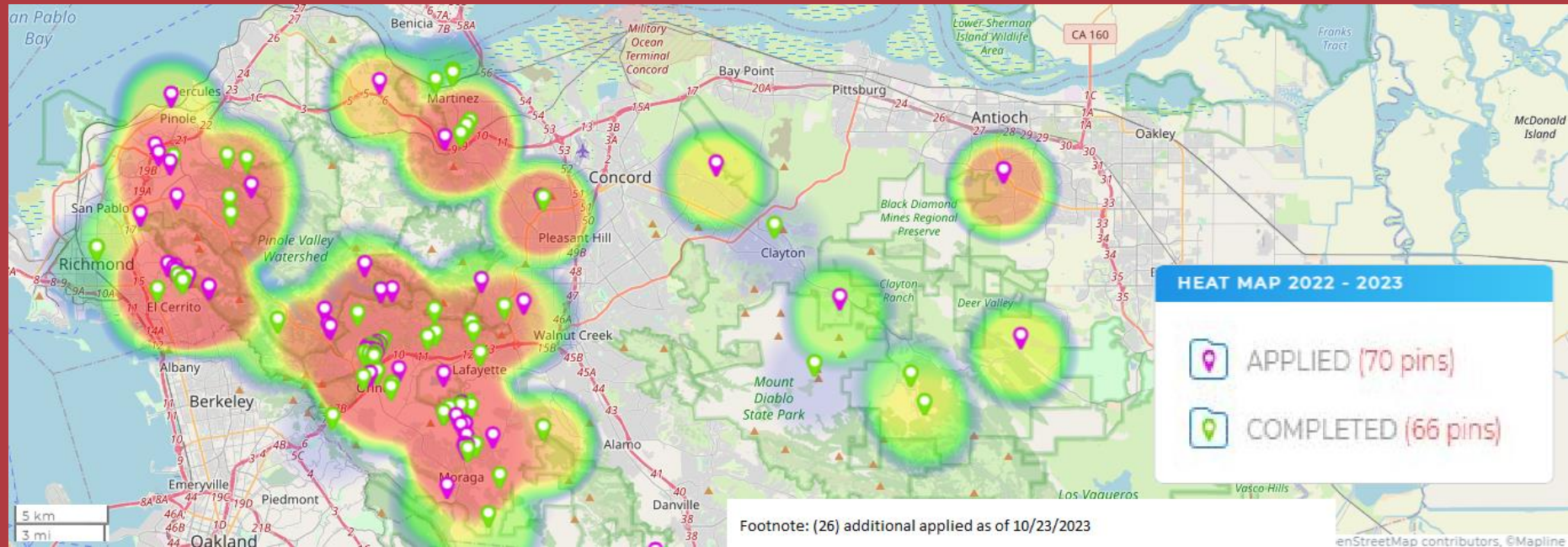

### City of Pinole Contract

Con Fire began providing service 3/1/23

- Fire Station 74 reopened
- Two Fire Stations now operating
- Increased Paramedic coverage
- Type 6 Wildland Engine purchased
  - Replaces 20 year old engine
- Con Fire hired additional personnel





## SUMMARY

Fire Station reopening and restaffing along with capital apparatus purchases and new construction projects to support these efforts are in progress and in some cases are complete.

Wildfire mitigation programs and related projects as well as augmented wildfire response with Crew 12 are now in place and interest in these programs is growing community by community.

The City of Pinole contract has been implemented and is operating smoothly, increasing service levels to Pinole and the surrounding communities.

### SUMMARY

1. One-time funds for construction and apparatus will be fully expended
  - a. Additional funds are needed to build FS 90 & FS 94
    - FS 90 estimated at \$26M versus \$15M 2021 estimate
    - FS 94 estimated at \$13M versus \$10M 2021 estimate
  - a. Ongoing Measure X funds for FS 94 are also budgeted to assist with capital construction costs along with the use of fund balance as needed to complete both projects
2. The balance of FY 22-23 funds of \$259,152 related to wildfire mitigation are needed to support the FY 23-24 plans for contractor-led mitigation work that was unable to be performed in FY 22-23
3. The balance of FY 22-23 funds of \$667,295 from the City of Pinole contract are proposed to be used to support the capital outlay of a needed ladder truck due to new development
  - a. These funds will be augmented by City of Pinole fire impact fees
4. The balance of FY 22-23 funds of \$1,669,707 related to Fire Station 81 operations and staffing are needed to support the increased fire station construction costs as noted in item #1 above
