**WHEREAS**

Description: Contra Costa County on May 13, 2025 contracted with American Pavement Systems, Inc. for work generally consisting of surface treatment work in the unincorporated East Richmond Heights area. The work done generally consisted of placing a type II fiberized slurry seal on various roads in the unincorporated area of East Richmond Heights. Work involved surface preparation, including; weed spray, crack sealing, pavement failure repair, edge grinding, removing existing thermoplastic stripes and pavement markings, setting survey monuments, placement of thermoplastic striping and pavement markings, all in accordance with the plans, drawings, special provisions and/or specifications prepared by or for the Public Works Director and in accordance with the accepted bid proposal. The project was located in the East Richmond Heights area, with the Western Surety Company, as surety, for work to be performed on the grounds of the County; and

The Public Works Director reports that said work has been inspected and complies with the approved plans, special provisions and standard specifications and recommends its acceptance as complete as of November 20, 2025.
