# Transitional Housing Program Plus (THP+) Laura Malone – Administrative Services Assistant CFS

THP+ offers housing and supportive services for young adults who have exited foster care, ages 18 up to 25 for no more than 36 months. THP+ is not a homelessness prevention program. The goal is to set former foster youth on a path to independence.

#### **Program Stats:**

EHSD contracts with 4 providers

**Total Housing Units: 37** 

FY 22-23 Clients Served = 46

FY 23-24 Clients Served = 46 (YTD)

Total contracted services: \$1,505,695

## Foster Youth to Independence Voucher Program (FYI) Laura Malone – Administrative Services Assistant CFS

The FYI Voucher Program offers housing choice vouchers to eligible former foster youth at least 18 years and not more than 24 years of age for no more than 36 months. Child Welfare must ensure supportive services are available to participants. Administered by HUD.

#### **Program Stats:**

Program Go Live - July 1, 2023.

EHSD CFS Clients Referred = 36
Vouchers issued = 23
Housed = 11
Searching/Finalizing Housing = 12
Pending Approval = 10
Declined/Opted Out = 3

## Housing Navigator Program - HNP Laura Malone – Administrative Services Assistant CFS

The Housing Navigator Program offers housing navigation assistance and direct concrete supports to help former foster youth ages 18 years and not more than 24 years of age to address housing insecurities. These services support the FYI Program.

#### **Program Stats:**

Services are contracted through H3 and delivered by Hope Solutions

EHSD CFS Clients Referred = 36 Direct Concrete Supports Issued as of December 31, 2023 = 0

#### **Funding**

Total contracted services: \$204,171

Funding supported 100% by Housing Community Development Grant (HNMP):

FY 22-23 \$ 36,002 (rollover fund) FY 23-24 \$168,169



# Bringing Families Home (BFH) Laura Malone – Administrative Services Assistant CFS

The Bringing Families Home Program offers supports to families in the child welfare system experiencing housing insecurities or homelessness, with a goal to increase reunification and prevent foster care placement.

#### **Program Stats:**

Program Go Live - February 2023

Services are contracted through H3 and delivered by Caminar, Inc.

EHSD CFS Clients Referred FY 22-23 = 20 Families

FY 23-24 = 58 Families
