SUBJECT: Establish speed limits on Pacheco Boulevard (Road No. 3915C), Martinez/Pacheco area.

The Contra Costa County Board of Supervisors RESOLVES that:

On the basis of an Engineering and Traffic Survey and recommendations by the County Public Works Department's Transportation Engineering Division and pursuant to County Ordinance Code Sections 46-2.002 – 46-2.012, the following traffic regulation is established (and other action taken, as indicated):

Pursuant to Section 22358(a) and Section 627 of the California Vehicle Code, no vehicle shall travel in excess of 40 miles per hour on Pacheco Boulevard (Road No. 3915C), beginning at Potter Street (Road No. 3485AA) and extending easterly to Morello Avenue (City of Martinez Road), Martinez area;

THENCE, no vehicle shall travel in excess of 30 miles per hour on Pacheco Boulevard (Road No. 3915C), beginning at Morello Avenue (City of Martinez Road) and extending easterly to Arthur Road (Road No. 3681), Martinez area;

THENCE, no vehicle shall travel in excess of 35 miles per hour on Pacheco Boulevard (Road No. 3915C), beginning at Arthur Road (Road No. 3681) and extending southerly to the Martinez City Limit at Sunrise Drive, Martinez area;

THENCE, no vehicle shall travel in excess of 35 miles per hour on Pacheco Boulevard (Road No. 3915C), beginning approximately 250 feet south of the Arnold Drive (Martinez City Limit) and extending southerly to First Avenue North (Road No. 3975L), Pacheco area;

THENCE, no vehicle shall travel in excess of 30 miles per hour on Pacheco Boulevard (Road No. 3915C), beginning at First Avenue North (Road No. 3975L) and extending southerly to Second Avenue South (Road No. 3975D)/Pleasant Hill City Limit, Pacheco area.

Traffic Resolution 1991/3451, pertaining to speed limits on Pacheco Boulevard (Road No. 3915C) is hereby rescinded.
