4. Meetings may be held in various locations and some locations may not be accessible by public transportation.
5. Meeting dates and times are subject to change and may occur up to two (2) days per month.
6. Some boards, committees, or commissions may assign members to subcommittees or work groups which may require an additional commitment of time.
7. **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARTINEZ
APPROVING THE APPOINTMENTS TO MULTIPLE ADVISORY BODIES**

WHEREAS, the Martinez City Council has adopted Ordinances which provide for the appointment of members to the City of Martinez Commissions and Committees ("Advisory Body") by the Mayor with the confirmation of the City Council; and

WHEREAS, the Measure D Citizens Oversight Committee, the Parks, Recreation, Marina, Cultural Commission (PRMCC), and Planning Commission have scheduled vacancies; and

WHEREAS, the Contra Costa County Advisory Council on Aging has an unscheduled vacancy; and

WHEREAS, applicants on file with the City Clerk's Office, as well as current Advisory Body members were notified of the vacancies and those interested were put on a candidate list for their desired seat; and

WHEREAS, Council Liaisons and Advisory Body Chairs assisted the Mayor with the review of candidates and the recommendations of appointment for each vacancy; and

WHEREAS, the recommendations are as follows:

- Appointment of Marcos Barajas to Measure D Citizens Oversight Committee
- Appointment of Peggy Huston to PRMCC
- Appointment of Rob Parolek to Planning Commission
- Appointment of Kathryn Monroy-Dexter to Contra Costa County Advisory Council on Aging

WHEREAS, these individuals accept their recommendation of appointment and are willing to serve and participate as members to their Advisory Body; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Martinez hereby confirms the Mayor's appointments as Advisory Bodies members according to the laws, ordinances, and regulations governing said Advisory Bodies, to the terms listed below:

- Marcos Barajas - Regular Committee Member to the Measure D Citizens Oversight Committee; new two-year term effective immediately and expiring June 30, 2026.
- Peggy Huston - Regular Commissioner to the PRMCC; new four-year term effective immediately and expiring June 30, 2028.
- Rob Parolek - Alternate Commissioner to the Planning Commission; new four-year term effective immediately and expiring June 30, 2028.
- Kathryn Monroy-Dexter - Regular Advisory Member to the Contra Costa County Advisory Council on Aging; effective immediately, assumes existing term which shall expire on September 30, 2025.


