

AMENDMENT NO. 1 TO THE PARTICIPATING ADDENDUM

This Amendment No. 1 (“Amendment”) to the Participating Addendum, dated October 15, 2025, (“Agreement”) is made and entered into as of February 3, 2026 (“Amendment Effective Date”), by and between Contra Costa County, a political subdivision of the State of California (“County”), and CDW Government LLC (hereinafter referred to as “CDW”), whose principal place of business is 230 North Milwaukee Avenue, Vernon Hills, IL 60061. The County and Contractor are sometimes referred to herein together as the “Parties,” and each as a “Party.”

Recitals

Whereas, CDW offers technology products and services and related solutions a cooperative purchasing agreement, identified as Contract No. 121923-CDW (“Master Contract”), awarded by Sourcewell, a State of Minnesota public agency, following a competitive solicitation.

Whereas, the County and CDW entered into the Agreement to allow the County to make purchases from the CDW under the terms of the Master Contract.

Whereas, because the County anticipates making a greater volume of purchases from CDW than originally anticipated, the Parties desire to increase the Payment Limit of the Agreement by \$500,000, from \$2,500,000, to a new Payment Limit of \$3,000,000, with no change to any other terms of the Agreement.

Amendment

NOW, THEREFORE, for good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the County and CDW agree to amend the Agreement as of the Amendment Effective Date, as follows:

1. Term. Section 2 (Payment Limit) of the Agreement is deleted in its entirety and replaced with new Section 2, to read:

“2. Payment Limit. County’s total payments to CDW under this Agreement shall not exceed \$3,000,000 (“Payment Limit”). Nothing in this Agreement obligates the County to make any purchase, or any particular volume of purchases, under this Agreement.”
2. Remainder Unchanged. Except to the extent that the Agreement is expressly modified by this Amendment, the remainder of the Agreement remains unchanged and in full force and effect.
