a. CoC Notice of Funding Opportunity (NOFO):

Homebase provided an update on the competition process for the Continuum of Care (CoC) of Notice of Funding Opportunity. The presentation covered the background, estimated available funding, local review and rank process, recommended priority listing developed by the Review and Rank Panel, appeals process, and the Council approval process of the priority listing. It was explained that the competition is now held every other year, and the usual competition processes will not be held in full next year. A total of six new projects were submitted but only four were recommended as total



exceeded funding amount available to the CoC. All projects, new and renewal, are ranked together and fall into either tier 1 or tier 2 of the priority listing, with tier one projects likely to be funded and tier two projects less certain. The Review and Rank Panel, made up of non-conflicted members of the Council on Homelessness, scored and ranked all applications. No appeals to the preliminary priority listing were made. The panelists shared their experiences and expressed gratitude for being part of the process. One of the COH members recommended to expand and support the interest of new projects to enter the competition moving forward. Deanne Pearn highlighted that Project Home SAFE from Hope Solutions is a DV Bonus project and asked to have it corrected on the priority listing.

b. Youth Advisory Board (YAB):

Caroline Miller reported that the Youth Advisory Board (YAB) has finalized reviewing the community needs assessment for youth and young adult homelessness and it will be released next month. YAB continues to work with young people on leadership development and working on their bylaws. YAB has received a lot of invitations to present at different agencies and events such as Homeless Awareness month, Contra Costa College as well as at Regional Youth Action Board in San Francisco, hosted by Tipping Point and facilitated by Homebase. An invitation will be sent out to the community to participate with YAB to put their input into the ending results of the Youth Homelessness and Demonstration Project once it is known whether YAB gets awarded the project or not. The group is also working on deepening their connections and networking skills.

a. Funding Updates:

Jamie Schecter provided updates on the Housing and Home Services Request for Proposal (RFP), previously known as Measure X. Based on feedback received in the summer, the following changes have been implemented: more clarification in the interview process and who gets offered an interview, inclusion of people with lived experience in the process of reviewing and making recommendations to the Board of Supervisors, additional language and bullet points to emphasize what the County's funding priorities are, more time for submission deadline, and using a different bidding platform. The RFP's



release target date was October 4th with a deadline at the end of November. Anyone interested in receiving email notifications and updates for Funding Opportunities can sign up for the newsletter here. Jamie also included funding updates on the CoC Builds NOFO program aimed to provide funding to acquire, build, or rehabilitate projects into Permanent Supportive Housing. The total funding is \$175 million dollars and communities may only submit one project proposal. H3 can apply for up to \$7.5 million. The overall timeline was shared, and the application deadline is November 21st, 2024. A total of 12 agencies submitted letter of interest. This and other grant opportunities can be found at this site. Additionally, it was announced that H3 was awarded for the Transitional Living Program (TLP) from the US Department of Health and Human Services Administration for Children and Families. The program is aimed to provide services for youth ages 18 to 21 to help them establish self-sufficiency and have sustainable living. The total funds awarded is \$250,000, which is non-competitive continuation funds available for up to five years. Lastly, the opening for El Portal Place, a 54-unit building of permanent housing, will be coming very soon. This program was funded by Homekey, with Contra Costa Housing Authority providing 25 housing stability vouchers.

a. <u>Presentation: Grants Pass Supreme Court Decision and California Executive Order N-1-24:</u> Sarah Ahmed gave an overview of the Supreme Court's Grants Pass ruling, which upheld public camping bans under the 8th Amendment's prohibition on cruel and unusual punishment. The California's Executive Order N-124 was also summarized with state agencies and departments being subject to Governor's authority, while non-state agencies being encouraged to adopt policies consistent with Caltrans' encampment approach. Michele proceeded to talk about the ruling's negative impacts on homelessness and the criminal legal system and discussed action steps that can be taken to decrease the impact such as educating officials, involving those with lived experience in decision-making, connecting with legal services providers, and expanding permanent housing capacity through noncarceral, person-centered programs. Furthermore, addressing racial inequities, advocacy with legal service provider partners, and a coordinated narrative against criminalization are needed. It was emphasized that The Grant's Pass Decision doesn't require local governments to enforce or create laws making sleeping outside or camping a crime. As part of questions and answer period from members and attendees, the following opinions/facts were discussed: a trend of encampments dispersed across the County was seen after a ruling, making it difficult to maintain relationships with those in need and who are displaced; a claim of an uptick in San Francisco's homeless population due to enforcement, and obtain some real data to refute this; an increased number of new faces in San Pablo, the need to hold



people's belongings for 60 days, a case with legal implications by arresting someone who was living in a park near a hospital where the person was receiving cancer treatment; and the potential use of HMIS to track people who may be losing contact.

b. Nomination for County Administrator's Office (CAO) Innovation Fund Panel:

Jamie discussed the Measure X Innovation Fund from the County Administrator's Office and the need for nominees for the review panel that will select proposals for the planning phase and recommendations for awarding up to \$1.95 million in Innovation grants. The reviewal and selection process will take place between October 2024 and January 2025. Nicole Green and Dani Jimenez were nominated to join the panel.
