Dear Clerk of the Board,

I am writing to express my strong support for community-driven guaranteed income (GI) pilots, drawing from my experience overseeing The Resilience Fund, a direct cash assistance program for survivors of human trafficking across the U.S. Our program provides up to \$500 monthly in unrestricted direct cash payments to participants for up to 18 months. The results thus far have been transformative, and findings suggest GI can both a solution in both preventing and responding to human trafficking. Our aim is to reduce chronic economic instability, which burdens both individuals and society, by offering cash without the excessive bureaucracy that often delays effective support.

Why Guaranteed Income?

Guaranteed income provides a complementary solution to existing public benefits by addressing gaps that often leave excluded individuals in cycles of poverty. It's important to note that GI is not intended to replace current systems, but rather to offer a streamlined, supplemental approach. By giving individuals direct, flexible resources, we allow them to take personal responsibility for managing their own financial stability, reducing dependency on reactive support services over time. Public benefits programs still play a crucial role in providing a safety net, and GI helps fill in the spaces where those systems may be too rigid to accommodate individual needs.

Demonstrated Impacts

The Resilience Fund has shown that participants use funds for essential needs such as housing, transportation, and childcare. Rather than undermining work incentives or reducing participation in public programs, the flexibility of GI empowers individuals to make better financial decisions and, in many cases, take proactive steps toward

employment and education. This approach reduces the pressure on other public benefits, as people become more financially stable and less reliant on emergency services. It's important to stress that GI doesn't negate the need for existing programs but enhances the overall system's effectiveness.

Efficient and Fair Program Design

Our program is designed to minimize administrative burdens, which makes it more efficient while still being equitable. Instead of relying on means testing or strict conditions, we use a trust-based system of self-attestation, allowing participants to define their own needs. This method doesn't eliminate the role of public benefits professionals—it simply reduces the administrative burden they face, freeing up their time for more complex, high-need cases. GI provides a support structure that reduces inefficiencies, giving public benefits professionals more room to focus on areas where their expertise is most needed.

The Case for Public Investment

Investing public dollars into a GI pilot is a responsible strategy that strengthens the overall support system without threatening existing public services. By providing direct income to individuals, we prevent larger crises that would demand higher levels of public intervention later. The outcomes of existing GI pilots show that reducing economic instability also reduces long-term dependency on other services such as emergency health care, housing subsidies, and criminal justice involvement. Rather than eliminating the need for public benefits programs, GI enhances their efficiency and impact, creating a more sustainable ecosystem of support.

Ensuring Sustainability

The Resilience Fund's pilot incorporates a thoughtful off-ramp strategy that gradually reduces payments, ensuring that participants don't face an abrupt end to support. Participants are also connected to benefits counselors who help them maintain financial gains and access other long-term services, including public benefits where appropriate. This ensures that the transition is smooth, and that participants continue to contribute positively to the community while maintaining their financial progress. Rather than undermining the role of public benefits, this approach works in tandem with existing systems to provide a broader safety net.

I am always more than happy to share more insights from The Resilience Fund's findings and work with other community groups with the goal of ensuring community-based programs complement and strengthen existing public services. The evidence is clear:

Guaranteed Income is an effective, responsible, and equitable solution that enhances the overall social safety net while empowering individuals to achieve long-term stability.

Subject: Research evidence on guaranteed income programs

Dear Contra Costa County Board of Supervisors,

As Contra Costa County is considering guaranteed income interventions, I am pleased to provide scientific evidence on guaranteed income interventions. I am on the faculty UCSF and much of my research has focused on the health impacts of economic interventions and socioeconomic status. Currently, I am an investigator on the Black Economic Equity Movement (BEEM) Project, a guaranteed income clinical trial among low-income Black young adults (aged 18-24) in San Francisco and Oakland, CA funded by the National Institutes of Health (ClinicalTrials.gov ID NCT05609188). We are investigating the effects of guaranteed income (\$500/mo for 12 months) on mental health outcomes, access to health care, and investments in the future (i.e., education, vocational training). We are using a randomized waitlist control design to evaluate effects: half of the participant receive guaranteed income in the first year and the remaining half receive guaranteed income in the second year. This design will allow us to evaluate the impact of receiving income compared to not receiving income (Year 1) as well as whether effects are sustained once guaranteed income is no longer being received (Year 2). This study began in 2022 and we are in the midst of collecting data for the study. We expect to share findings near the end of 2024 and would be happy to share them with the Board.

Guaranteed income interventions are proliferating around the country and the rapidly growing scientific evidence base demonstrates that providing no-strings-attached cash can be a powerful and efficient tool for individuals and communities to counter financial shocks, meet basic needs, and foster social inclusion among marginalized groups. The existing piece-meal social safety net can be slow, notoriously difficult to navigate, and fraught with many barriers to receiving resources. Individuals and households who receive guaranteed income can fill in the gaps to meet basic needs like housing, food, transportation, and children's needs—spending on basic needs is perhaps the most robust evidence to-date. Importantly, the impact of being able to meet basic needs should not be understated; it can be deeply meaningful. In my research, I interviewed one formerly unhoused participant who was able to use guaranteed income to prevent homelessness at a particularly vulnerable time; her credit union closed causing her to not be able to receive her paycheck and she was trying to piece together assistance for rent. She said, "So I was falling behind on rent, I was falling behind on bills, I couldn't eat...a lot of the organizations that help are there, it's really unreliable with their resources. Sometimes they have things, sometimes they don't...and that was around that time when you guys called about BEEM...and I had an extra 500 to kind of keep me afloat...the more I talk about about my journey to being

housed and just becoming one into adulthood and getting my autonomy slowly back, it's very—I don't know. It's like synchronistic or like in a movie or something like that, but a lot of disastrous things will happen and then magically come in."

This alludes to the importance of guaranteed income, not only to individuals, but to families and communities. At the Guaranteed Income NOW conference in Detroit in June 2024, a recipient reflected about the difference she saw in her kids, "A child that grows up with everything they need is a different child than one who doesn't." This is underscored by results from the Great Smoky Mountains Study which found that youth in households who received income supplementation were less likely to have psychiatric disorders and abuse or be dependent on alcohol or cannabis *in adulthood* than youth who did not receive income. In addition, guaranteed income can influence how recipients see themselves within society, helping them feel that their presence and contributions are valued, especially when they are engaged in low-wage work. For instance, evidence from Finland show that guaranteed income increases people's trust in others and in social institutions. And data from guaranteed income projects in the U.S. also show that people use guaranteed income for the good of others; we consistently find that individuals and households consistently use guaranteed income to support others, which can help strengthen social ties and communities.

Findings are mixed about questions surrounding some of the fears about guaranteed income disincentivizing work. The Denver Basic Income Project for people experiencing homelessness found that those who received more guaranteed income were more likely to be employed full-time compared to those who received a smaller token amount. However, Open Research recently published findings from their guaranteed income trial over three years which found a modest decline in work (1.3 fewer hours/week) but increases in entrepreneurship and active job searching, suggesting that guaranteed income may have afforded people the ability to take career risks and pursue new ventures. The BIG:LEAP guaranteed income program in Los Angeles found that recipients found better jobs and were also able to enact other big changes in their lives, including escaping domestic violence.

The movement towards guaranteed income is also expanding at multiple levels including reenvisioning how to apply public funding and deliver social services. Flint, Michigan has applied Temporary Assistance for Needy Families (TANF) funding to support a citywide prenatal and infant guaranteed income program. California is currently implementing a state-wide pilot through the California Department of Social Services. Government entities are also exploring how they can infuse guaranteed income principles and values into existing social services. For example, the U.S. Department of Housing and Urban Development is encouraging local housing authorities to experiment with giving cash to renters acknowledging that existing voucher systems are fraught with years-long waitlists and voucher discrimination.

Lastly, one thing is clear, guaranteed income is a cross-cutting intervention and can be regarded as a pathway to equity. Studies on tax credits (e.g., Child Tax Credit, Earned Income Tax Credit) have shown that getting cash back into the pockets of low-income households reduces income inequality. Communities across the board—historically disadvantaged communities, disabled communities, formerly incarcerated communities, low-income families—see guaranteed income as a solution that can work for them and uplifts their autonomy and self-determination.

There is much more that needs to be learned about guaranteed income and how it works within our social safety net today and for different populations. This an exciting time to be a part of understanding if and how guaranteed income works. My research also includes other studies evaluating the impact of guaranteed income, including evaluating housing outcomes (funded by the UCSF Benioff Homelessness and Housing Initiative), and two proposed studies (pending funding): 1) understanding differences in guaranteed income impact by neighborhood contexts and 2) testing the impact of guaranteed income on HIV outcomes among formerly incarcerated individuals living with HIV. Once results are available, we would be happy to share findings with the Board. Also, if Contra Costa County starts a guaranteed income program, this will also contribute to our knowledge of how guaranteed income works among Contra Costa's target populations, how it interacts with the local context, and its impact on desired outcomes.

I write as someone who has worked closely with the indigent and vulnerable in Contra Costa County for over 23 years and who shares your commitment to ensuring equity in our local community. I would like to express my strong support for funding a guaranteed basic income pilot program for individuals reentering the community after being incarcerated.

When community members are ordered to serve time in custody, whether it be for a matter of days or for several years, the criminal system is destabilizing to them as it removes them from their family, employment, housing and other societal connections in our community.

Upon release, as these individuals face an increasingly uphill battle to reestablish those connections, the destabilization can have dramatic long-term effects including rearrest and reincarceration. The financial costs for rearresting and reincarcerating these individuals are dramatically higher than the costs to restabilize them. In fact, the costs for restabilization can have a net financial gain when these individuals are able to contribute to our community's economy and taxpayer base. Stabilizing individuals in our local community saves money.

This policy would have a direct, positive impact and reverse many of the negative consequences for individuals the criminal system has incarcerated. It takes a village to care for our entire community. It's imperative that the County's safety net provide each previously incarcerated individual with a reentry strategy that directly restabilizes them and helps reestablish fractured connections to our community. I strongly support the funding request for a guaranteed income pilot for the reentry population in Contra Costa County. As the Director of the guaranteed income program Just Income by Community Spring in Gainesville, FL, I have witnessed firsthand the transformative effects of guaranteed income on formerly incarcerated individuals and their communities.

### Why Guaranteed Income is Essential

In a society where punitive policies systematically deny individuals with criminal records access to vital resources, the cycle of poverty and re-incarceration is perpetuated. This unjust cycle traps individuals in a relentless struggle, where financial instability leads to desperation and ultimately to imprisonment. We can break this cycle. Investing in guaranteed income is not just a program—it's a revolutionary step toward restoring dignity, fostering independence, and creating equitable opportunities for our most vulnerable citizens.

### **Proven Strengths of Guaranteed Income**

Just Income has proven to be a lifeline for formerly incarcerated individuals in Alachua County, providing 12 months of guaranteed income for people recently released from incarceration. This targeted support addresses immediate financial needs, enabling participants to regain control of their lives. To date, we have supported 137 people with over a million dollars in direct cash assistance. Our results speak volumes:

- Empowered Lives: Participants have reported increased financial stability, which significantly reduces reliance on survival tactics that lead to re-incarceration. Our program has achieved a remarkable 43% reduction in money-related re-incarceration rates. This is not just a statistic; it's a testament to the transformative power of guaranteed income.
- Employment Success: The financial security provided by Just Income empowers individuals to seek employment that aligns with their skills and ambitions. Participants are breaking free from exploitative labor conditions and moving towards stable, fulfilling jobs. For example, Anthony utilized Just Income to stabilize his finances and pursue a commercial driver's license. He stated, "The program allowed me to be free from my burdens," emphasizing how guaranteed income enabled him to focus on his aspirations rather than his struggles.
- Strengthened Families: By alleviating financial burdens, guaranteed income enhances family dynamics and fosters a sense of belonging and purpose. Vee, a participant who stabilized her life through Just Income, shared, "Hope goes a long way for people accustomed to hopelessness."

- This program allows participants to transition from financial dependents to active contributors within their families and communities, significantly improving their relationships.

As the Director of the guaranteed income program Just Income by Community Spring in Gainesville, FL, I have witnessed firsthand the transformative effects of guaranteed income on formerly incarcerated individuals and their communities.

Dear Contra Costa County Board of Supervisors,

Monument Impact is writing to support the allocation of \$5.75 million dollars for a Guaranteed Income pilot program to serve individuals in Contra Costa County. This service will provide a long-term strategy for financial stability and offer much-needed support to our most marginalized and vulnerable populations that often face significant challenges and instability.

Guaranteed income programs significantly contribute to a person's ability to maintain a stable life. Unrestricted cash assistance can help find or keep stable housing and employment, address unexpected transportation costs, invest in education, and keep food on the table. We believe everyone should access these necessities without the stress of living paycheck-to-paycheck. In addition, guaranteed income programs address gaps in the existing social safety net and can address deeply rooted racial and economic inequities in Contra Costa County.

Since November 2023, ELEVATE Concord, Monument Impact's Family Economic Equity Pilot, has provided unrestricted cash assistance to 120 low-income, single-parent families. Families are receiving \$500 a month for a year and, in addition, received a one-time gift of \$2,500. As of July 2024, the program has been extended until December 2024 with scaled-down payments. Many have used this cash assistance to pay their rent, buy groceries, fix their cars, buy medication, and keep up with other daily expenses. Beyond basic necessities, parents have expressed a sense of relief - data captured from our first quarter showed that participants who responded to our survey experienced a 50% decrease in anxiety and a 31% decrease in stress since the beginning of the program. The cash assistance they are receiving has allowed them to spend more time with their children and participate in community events. Some have switched to higher-paying jobs or have gone back to school. Through this program, we also support participants with wrap-around services, like access to our mental health and emerging business programs, technology training courses, and leadership development opportunities. The impact of ELEVATE Concord is clear - guaranteed income improves families' quality of life.

Investing community dollars into a Guaranteed Income pilot program is an innovative and tried-and-true approach that can undoubtedly help break the cycle of intergenerational poverty. We strongly urge the Board of Supervisors to allocate \$5.75 million in Measure X funds to create a countywide guaranteed income pilot program that will empower and uplift our community by offering concentrated support and consistency to constituents who need it most.

Step-Up Durham enthusiastically supports Dr. Rachel Rosekind's request for \$1M from the AB 109 reserves to fund a guaranteed income pilot for formerly incarcerated individuals in Contra Costa County.

From 2022-2023, StepUp Durham served as the program administrator for the City of Durham's first guaranteed income pilot, providing 109 formerly incarcerated individuals with \$600/month for one year. Seeded with \$500,000 from the former CEO of Twitter, Jack Dorsey, StepUp Durham raised over \$200,000 from additional private donors to provide monthly disbursements. The University of Pennsylvania serves as our researcher and will publish outcomes of this pilot this Fall. What we know thus far is that only two individuals of the 109 were convicted of charges during the pilot, and those charges were incurred before the pilot began. (For North Carolina, the recidivism rate is 40% - 40% of individuals coming out of incarceration return within the first three years.) Our 1.8% recidivism rate says to us that when individuals have the resources they need to thrive, the impact on recidivism is significant. We have heard that, in addition to providing for participants basic needs, our pilot, called Excel, allowed individuals to invest in themselves. One individual, Tydricka, was able to invest in a nonprofit she launched for young women with the goal of having them make different decisions from the ones she had made that led her to incarceration. Tyler, another of the 109, invested in his continuing education. Every story we heard were individuals who, for the first time in a long time, felt like they were able to move beyond their past and focus on their future.

The mission of StepUp Durham is to empower job seekers in the Durham community who face challenges to employment. We do this by providing them opportunity and access to essential resources and holistic support to enhance lives and build sustainable employment, thereby fostering personal and community growth. Understanding that employment is the first step to stability, StepUp Durham offers resources to find and sustain employment, as well as personalized employment counseling, job referrals, and post-employment support. Our programs are designed specifically for individuals experiencing challenges to finding employment. This past fiscal year, over 40% were justice-involved, 20% were in recovery, and 51% had housing instability. Since launching in 2015, StepUp Durham has served over 1,000 individuals through our various programs.

StepUp Durham believes that when the most marginalized of our communities thrive, everyone thrives. We believe the \$1M from the AB 109 reserves to fund a guaranteed income pilot for formerly incarcerated individuals in Contra Costa County will impact the health and wellness of the entire community.

#### **Dear Esteemed Board of Supervisors:**

As the President of the Santa Clara County Board of Supervisors, District 4, and a founding member of the national coalition of Counties for a Guaranteed Income, I am writing to strongly encourage you to approve funding for a guaranteed income pilot program in Contra Costa County.

To date, Santa Clara County has invested \$13 million to fund four pilot programs that by 2025 will have successfully served almost 900 participants. We are partnering in several more pilot programs and will continue to seek opportunities to expand both the funding sources and the number of people who could benefit from these programs. Through these programs we are serving former foster youth, young moms, high school seniors experiencing homelessness, and other targeted populations. Within the last year, my colleagues also voted unanimously to support a guaranteed income program for people exiting incarceration, in part because our sheriff and a local police chief said implementation of these innovative programs would increase public safety.

Lack of basic support makes maintaining the conditions of probation or parole (drug testing, treatment programs, paying fines, traveling to mandatory classrooms or programs) extremely difficult. Too often, people end up back in jail and restarting the cycle of incarceration though they have not caused additional harm. This cycle is costly to the individual, their families, and the public, and does nothing to improve our overall safety.

A guaranteed basic income plays a significant role in stabilizing individuals who depend on the county safety net and in countering the myth that poverty is a moral failing of individuals rather than the result of systemic failures.

This idea isn't new, and it isn't radical. There are numerous examples of guaranteed basic income pilots across the country that have demonstrated positive and sustained impact on pilot participants and, by extension, on their communities. Thanks for your attention and I sincerely hope you to approve funding for guaranteed income in Contra Costa County.

Dear Contra Costa County Board of Supervisors,

On behalf of First 5 Contra Costa, I urge you to support piloting guaranteed income strategies in our county using Measure X funding.

First 5 Contra Costa served on the Guaranteed Income Working Group composed of county departments, advocates, and service providers that aimed to learn more about guaranteed income approaches and responsiveness of residents in our county. What we learned from that process underscored what we already knew from the data we collect from families with young children – many families are struggling to make ends meet in our high-cost county and do not have what they feel they need to support their children. In 2020, 9% of families with children under the age of 6 in our county lived in deep poverty, defined as 50% of the Federal Poverty Level (or with an annual income of \$13,875 for a family of four), while the Self Sufficiency Standard for our county indicated that a family that size would need an income of \$106,000 to make ends meet.

Guaranteed income programs have proven to be effective in addressing income inequality through streamlined and equity-drive approaches. Several First 5 agencies across California have partnered with county departments, service providers, cities, and philanthropy to implement guaranteed income programs focused on families with young children. We are pleased that these programs, such as the <u>Sonoma County Pathway to Income Equity</u> which provides \$500 a month to 305 families for 24 months, are finding that participating families are making progress towards economic stability and their ability to meet everyday needs.

We are excited that the current proposed pilot for our county includes families with children under age 6. Research shows that investing during a child's first 5 years of life is one of the most cost-effective strategies for fostering a healthy community for everyone – not just the children and families receiving supports.



Dedicating resources to support children ages 0 to 5 not only makes sense in terms of where to invest public dollars and how to have the biggest impact on children and families' lives, but also delivers on what voters were promised when they passed Measure X. The ballot language listed early childhood services as one of the areas Measure X funding was intended to support. Yet to date only 3.5% of Measure X funds have been dedicated to early childhood services.

I believe it is urgent and timely for Contra Costa County to invest in our neediest families with young children to fund guaranteed pilot programs in our county.

Re: Letter of Support for Guaranteed Income in Contra Costa

Greetings Contra Costa County Board of Supervisors,

In 2019, the American Medical Association cited poverty as the 4th leading cause of death in the United States (JAMA, 2019). Since then, the authors of this formative study have identified the COVID pandemic as an "aggravating event" increasing the association between poverty and mortality, and with an increase in the number of deaths due to poverty (Brady, et al, 2023).

This is why RYSE is grateful and appreciative that the Board of Supervisors is holding the October 22nd Forum to learn about Guaranteed Income, and considering how the County can sustain and deepen such investments as pathways towards increased health, safety, and security for all of our communities.

RYSE is also grateful and appreciative of all the labor and love that went into *Ensuring Opportunity's Guaranteed Income in Contra Costa: Primer and Roadmap to Strengthen Our County's Safety Net*. RYSE fully supports the recommendations set forth in the Report.

As mentioned, the COVID pandemic and Racial Reckoning took place a year after the formative study was published, and have only shone a brighter light on the embedded structures of inequity and injustice that bind our systems and institutions together - through deeply held judgment, stigma, and discrimination (de facto and de jure) of too many of our struggling and surviving community and kin.

As well, the Pandemic and Racial Reckonings also made more visible our interdependence, interconnectedness, and ability to take care of each other by collectivizing resources for community care. As EO's Report outlines, the impacts and benefits of GI resources (of collectivized resources) on participants' health, safety, security, sense of belonging and connectedness, and aspiration for the future reflect and reveal the clarity of trusting and following the lead of participants in how they prioritize, choose, and invest in their and their families' well-being with tangible, consistent resources.

RYSE has seen and felt these impacts with young people we serve through our Youth Emergency Fund, which launched shortly after the COVID Shelter in Place began, as well as in our current GI pilot: Direct Cash Transfers for Youth and Young Adult Homelessness Prevention. We are also seeing and feeling the need for deepened and extended resources, committed resources that will move us from pilots to programs to embedded policies and investments. The worry and anxiety of when a GI pilot ends is too real, as is the growing crisis of youth homelessness, housing insecurity, cost of living, increased isolation, distress. The lack of



real-time, sufficient supportive resources and spaces that young people need and deserve are creating conditions in which exploitation, violence, and risk to health are the costs and jobs of survival.

Guaranteed Income lessens the risks and impacts of harm and distress, of poverty. The risks of not investing are much greater than the amount recommended by EO's Report. By centering the priorities and needs of our most structurally vulnerable communities, through direct and unrestricted financial resources, we can support safety, belonging, and stability for all of us. And in fuller perspective, the funds provided through GI projects remain far less than the benefits and financial breaks that wealthy and owning-class families, communities, and generations receive, often without ever having to apply, prove worth, or be measured.

RYSE hopes for and calls on the Board of Supervisors to lessen the harms, to save lives and livelihood, for those the systems have made vulnerable by fully enacting the recommendations and resources set forth in EO's Report.

Dear Board of Supervisors,

Rubicon Programs supports the Community Advisory Board's recommendation to use AB 109 reserves to allocate \$2 million in funds for a guaranteed income pilot program for Contra Costa's justice-impacted community members. This will be an important pilot program that will move Contra Costa justice-impacted residents from the conditions of poverty to financial stability.

Rubicon Program's mission is to transform East Bay communities by equipping people to break the cycle of poverty. Much of our work is focused on helping formerly incarcerated people successfully reenter the community and find stable, meaningful employment. In the last program year alone, Rubicon's anti-poverty work impacted the lives of 2,728 participants across the organization, including 1,494 new individuals. Our participants are assigned a trained impact coach who will provide one-on-one coaching for up to three years. The impact coach will join the participants as they attend a two-week comprehensive workshop series, which addresses four issue areas: assets, income, wellness and connections as well as legal services, structural causes of poverty and digital literacy. For assets, we have financial coaches who teach financial literacy, consumer rights and train participants to grow their savings, repair credit, build a budget and invest. For income, we have employment coaches who will help participants reentering society find immediate employment to meet their short-term needs based on their current skills and experience. Then our career coaches will work with them to chart a long-term career plan to attain more pay, training and job certifications. For wellness, our wellness coaches provide culturally responsive counseling, services and referrals to address the participant's emotional and physical health needs. For connections, we help participants establish relationships and community networks to build a career, raise a family and advocate for themselves through support groups like men's and women's group or family workshops, leadership training, restorative practices and community advocacy. Our legal services team work to provide legal advice, minor representation around record sealing, expungement and child support and employment discrimination issues. We try to encompass our participants with as much support and resources as possible as they work to transform themselves.

Our Returning Home Career Grant program was our pilot project to accomplish our mission of ending poverty in the East Bay. Rubicon Programs was the lead agency in the Better Careers

Design Group (BCDG) that launched this guaranteed income program that provided 20 participants with \$1500 per month for 18 months and mentorship in Alameda County. With the help of Alameda County Workforce Development, Probation Department, Growth Sector, Third Sector and the James Irvine Foundation, we decided to have a higher monthly payment amount than other pilot programs in the state so that it can have a greater impact on participant's lives. Our program was limited to referrals from community-based organizations (CBOs) doing prerelease and post-release services to justice-impacted adults and they nominated participants for whom this opportunity would alleviate barriers to employment and career mobility. One part of designing this pilot program was gathering input from different stakeholders. We had 56 stakeholder interviews - ten employers, ten CBOs service providers and 36 justice impacted job seekers and a common theme that arose was a deep desire for autonomy and agency. As the program was implemented, we had interviews, surveys and feedback sessions from the participants, their family and friends and quarterly check ins with CBO service providers. The results from our program were tremendous. Participants were able to build careers, pursue personal goals and improve their overall quality of life by removing financial stressors, have more social connections and center their wellness. The impact for our program participants was endless: some were able to get married, have more family outings, didn't need to get another job to make ends meet, received job promotions or pursued new careers, got better housing or purchased new cars and some participants used this opportunity to pursue a college degree. Our services continue to be available to any of our pilot program participants who would or have participated in our two-week workshop to ensure that they have the tools and resources needed to attain financial stability.

Rubicon Programs believes that these structured guaranteed income programs are an effective and impactful avenue to combat poverty in the East Bay. It is why we support the Community Advisory Board's recommendation to use AB 109 reserves to fund a \$2 million guaranteed income pilot program for Contra Costa's justice impacted community members. I strongly endorse Contra Costa County's deliberation on allocating funds to establish a Guaranteed Income Program at the forthcoming Contra Costa County Board of Supervisors meeting scheduled for October 22, 2024. As the Los Angeles County (County) Supervisor of the Second Supervisorial District, I would like to note my colleagues and I have implemented similar initiatives within our County - most notably through Breathe: Los Angeles County's Guaranteed Income Program (Breathe). We have witnessed firsthand the significant impact that direct cash payments can have in assisting our most vulnerable community members.

To illustrate, Breathe allocates \$1,000 per month to 1,000 County residents for a duration of three years. Through collective partnership, we were fortunate enough to expand the program to 200 former foster youth last year. In August 2024, the County's Board of Supervisors approved my motion to expand the program once again to more than 2,000 former foster youth in care between the ages of 18 and 21. Former foster youth, in particular, often face a pivotal moment in their lives as they transition out of the foster care system, lacking the social and financial safety nets that their peers typically benefit from. Offering direct, unconditional cash assistance empowers our foster youth to access educational opportunities, achieve stable housing, and develop a sense of financial security during this pivotal period of their lives.

Additionally, Breathe is undertaking a robust research and evaluation process conducted by the Center for Guaranteed Income Research (CGIR) at the University of Pennsylvania. CGIR is collecting one of the largest bodies of evidence that demonstrate the power guaranteed income projects have towards achieving economic well-being and mobility, housing security, increased health and mental health, increased education and job

outcomes, and an increase in financial acuity. Each of these outcomes underscore the effectiveness direct cash payments offer as an intervention for individuals and families experiencing poverty. As a result, guaranteed income programs like Breathe are a valuable investment in community well-being and resilience.

Most importantly, a guaranteed income program in Contra Costa County offers transformative opportunities to residents, helping them achieve stability and a sense of hope for their future. Your leadership could pave the way for systemic change and uplift many in your community while informing local policy and practice change. As the testimonies of our constituents show, guaranteed income programs provide stability, promote equity, and serve as a powerful tool in our collective efforts to eradicate poverty.

## **Re: Support of Guaranteed Income Pilot Program**

Dear Contra Costa County Board of Supervisors,

On behalf of East Bay Housing Organizations (EBHO), I write to share our strong support for the County allocating \$5 million from Measure X funds to support Guaranteed Income Pilots in Contra Costa County.

EBHO is a non-profit, member-driven organization with over 400 organizational and individual members. For 40 years, we have worked to preserve, protect, and create affordable housing opportunities for low-income communities in Contra Costa and Alameda Counties by educating, advocating, organizing, and building coalitions.

Guaranteed income is an equity-based, data-driven, and prevention-focused public health strategy that responds to the urgency of residents' needs and circumstances. Guaranteed income programs are a strategy to respond to acute problems such as housing cost burdens, which are most severe for extremely low (ELI)- and very low-income (VLI) households. 72% of ELI households and 46% of VLI households in Contra Costa County pay more than half their income on housing costs, compared to 1% of moderate-income households.¹ Additionally, guaranteed income serves as an intervention towards the well-documented racial wealth gap, which sustains disproportionate harms and negative outcomes toward people of color, particularly for Black and Latino communities.

Data from guaranteed income pilots nationwide that serve diverse populations show uniformly positive impacts on housing, financial security, education, health, belonging, and self-worth, as well as concrete achievements such as paying off debt, boosting savings, and securing better jobs. Aside from providing for basic needs, these regular, unconditional payments build community members up by connecting them to services; advancing their education; and attending to their social and emotional well-being.

## Responses to Supervisors' Concerns re Guaranteed Income October 22, 2024

Q: How do we justify serving a limited amount of residents who could benefit from this pilot program? Relatedly, how do we choose which population(s) to focus on?

A: Guaranteed income (GI) is part of a movement we are trying to scale and elevate, building upon successes with specific populations to broaden to new participants. As we are seeing people use GI as a bridge toward increased financial resiliency and economic mobility (and so much more!), we can scale these successes to reach incrementally more people. Cities and counties, like Austin, Cambridge, Los Angeles, and elsewhere, are actively looking for other funding streams that can be channeled to support direct cash programs for additional populations. But we begin with targeted investments in populations that are most proximate to harms, burdens, and barriers and most poised to benefit from a direct, timebound infusion of cash at critical thresholds. Many of our residents are struggling to get by, lacking sufficient and flexible financial resources to sustain themselves and their families, and are thereby being forced to hierarchize basic needs and navigate scarcity. This problem warrants a targeted response. Guaranteed income is a promising policy pathway for local governments to directly support and invest equitably in their residents so they can tap into more resources and opportunities.

While this goal of universal thriving is ambitious, and cannot be fully achieved through a small-scale pilot, designing specific implementation strategies in its service moves us closer to universal realization. These commitments also embed an infrastructure of care and recognition of shared humanity into public policymaking and funding decisions, paving the way for transformative changes that fortify our county's collective well-being and affirm its diversity.

We have recommended four priority populations in Contra Costa. Not only do these populations merit public investment, they are also closely tied to positive outcomes gained through guaranteed income pilots nationwide. Housing-insecure and unhoused pilot participants are moving indoors, finding stable housing, and being connected with additional

services and resources. People returning to the community after incarceration are gaining employment and economic stability that prevents recidivism and reunifying with their families. Former foster youth are using guaranteed income as a bridge to return to school, open banking accounts, and attain greater independence and stability. Finally, economically marginalized families are reducing debt, building savings, and becoming better positioned to be the parents they want to be, conferring dual-generation benefits.

Guaranteed income centers equity and redress. It requires that we look closely at where our resource and opportunity gaps are and act boldly and swiftly to fill them in, by all means necessary. This is achieved through investing directly in our residents—in their hopes and dreams and in their hope and well-being.

Regarding inclusivity and net prosperity, it's worth noting that the inauguration of our country's public welfare system was intentionally exclusionary. These programs, and other entitlements that followed, laid the groundwork for many of today's ongoing resource and opportunity disparities. For example, the 1944 Servicemen's Readjustment Act, more commonly referred to as the GI Bill, was intended to distribute benefits in homeownership, education, and unemployment. But its local implementation was undeniably inequitable, resulting in disproportionate benefit to white veterans, the legacy of which is evident in the gap between family wealth of white and Black veterans (32 times, according to Meschede et al., 2022). These foundations generated decades and lifetimes of disparate asset-building and mobility opportunities. Similarly, Social Security is a benefits program that millions of undocumented immigrants pay into every year but cannot derive any direct benefit from. Our safety net programs are already self-selecting and exclusionary.

The mortgage deduction, while not a traditional safety net program, essentially functions as one by building and fortifying generational wealth and providing economic stability for millions of Americans who are disproportionately white (Holtzblatt et al., 2024). Notably, the net benefits to white Americans derived from public dollars are not limited to the mortgage

deduction but extend to a host of other critical wealth- and asset-building mechanisms, namely capital gains and dividends, deduction for pass-through income, charitable deduction, home mortgage interest deduction, and deduction for employer-provided health insurance, all of which were recently found by the Treasury Department's Office of Tax Analysis to disproportionately benefit whites (Cronin, et al., 2023). In these examples, the receipt of public dollars is predicated upon eligibility that is inherently exclusionary and overwhelmingly defined by incidence of birth, zip code, and skin color. And, critically, we do not ask recipients of those public dollars how they are spending them. Guaranteed income is a direct response to legacies and ongoing systems of exclusion and a net widening that promotes inclusivity, equity, and leveling up.

# Q: What happens when the money runs out? How is GI anything more than a short-term solution?

A: First, Temporary Aid to Needy Families (TANF) has a five-year lifetime limit, so the benefits cliff is built into our legacy social safety net. This "hard stop" is accompanied by built-in systemic disincentives for recipients to earn more income and/or acquire savings and assets due to eligibility thresholds, potential abrupt termination of benefits, and net loss of income as a result. Second, GI is not a cliff; it is a bridge that meets people where they are and empowers/supports them to move to where they want to go. People with differing needs, ambitions, and circumstances in communities across the country are using guaranteed income as a springboard to opportunity and mobility. They are harnessing the investment to set personal goals; connect to additional services, including social safety net programs and other public resources; and build agency, self-sufficiency, and brighter futures.

The evidence overwhelmingly shows how a short-term investment is having a transformative impact on people's lives that leads to sustained benefits and positive outcomes for themselves and their families. For example, GI participants are:

- Returning to college to earn their degrees
- Gaining new skills and credentials through training and certificate programs
- Spending more time with their children
- Finding jobs that are meaningful to them and allow more flexibility to care for family members
- Paying down predatory debt and building up savings
- Building relationships with neighbors and giving back to their communities

This is not a cliff effect; it is a bridge effect. Guaranteed income is truly building pathways out of poverty and on-ramps to opportunity. Moreover, instead of fostering dependency, it is generating hope, resiliency, and agency.

Additionally, aftercare support, which entails connecting participants with continued services and resources like employment assistance, educational opportunities, and/or long-term housing programs such as rapid re-housing or permanent supportive housing, ensures participants are able to sustain progress and gains made during the pilot. Research shows that participants are considering how to best use the additional income during the period they receive it in order to set themselves up for future success and that providing unconditional cash at a critical time is a way to meet people where they are with maximum flexibility and agency, bolstering goal-setting and enabling new chances and choices.

Finally, guaranteed income is not a panacea: it is not a singular solution to any social ill or individual circumstance. Rather, it is a potent strategy and pointed tool within a larger vision of societal welfare that centers equity, prevention, and security. Its systems-level focus shifts the locus of attention and intervention from an individual's actions to systemic obstacles and impacts. It is both unreasonable and undesirable to expect guaranteed income, or any financial support program for that matter, to (re)solve numerous structural and systemic barriers and personal limitations that many of face in their quest to lead healthy, stable lives and care for their families. This recognition is the crux of reimagining the safety net, i.e., building more robust, reliable, flexible, and holistic systems of care and accountability that promote opportunity, mobility, and well-being for all.

## Q: How do we leverage funding to serve the most people?

A: This question is inadequately framed. While it is true that, for example, a \$100 public benefits renewal stipend would be provided to far more residents than a monthly payment of \$1,000 for 18 months, we are striving for qualitative impact not quantitative equivalence. In fact, we are requesting that the County make a transformative investment via guaranteed income, where the emphasis is on creating the conditions for resilience, stability, mobility, and, just as critically, agency, flexibility, and dignity. Thus, the most potent and accurate question is: How do we leverage funding to serve people in the most meaningful way possible? We believe that a GI pilot that lasts 18 months and provides residents with up to \$1,000 a month is the answer, as evidenced by the sustained, generational impacts exhibited by pilots and other cash transfer programs running to date.

Additionally, supervisors have asked whether a GI program sufficiently leverages state and federal funds and existing programs. Initiating a county-funded pilot in Contra Costa is a proactive investment for future leveraging of new funding sources and initiatives that are being spawned by the state- and nationwide campaign to reform, modernize, and reimagine our social safety net. By joining the dozens of other cities and counties in California that have launched pilots, Contra Costa builds the case for additional state investment, the start of which has already been codified in Assembly Bill 2263, and, more expansively, for a federally-funded guaranteed income. This is a progressive vision—one that acknowledges deep system harms and the necessity of reform and meaningfully accounts for the economic realities and structural barriers that impede individuals' and families' stability, mobility, health, and well-being. In other words, Contra Costa's investment today sets the stage for leveraging opportunities (both financial and programmatic) tomorrow.

Lastly, the program's evaluation has deep potential to contribute to improving the lives of residents who are not selected to participate in this pilot. Evaluation findings should present avenues where policy and programmatic changes could institutionalize some of the strongest benefits to residents and improve our existing public benefits programs. Thus, while the

number of residents who will be directly impacted by this pilot is relatively small compared to the number of those who would be eligible for it, its evaluation will have significant and sustained influence on future program design, policy decisions, and fiscal allocations, both locally and at the state and federal levels.

## Q: What should be the role of supportive services?

A: Thoughtfully-designed pilots wrap opportunities for services and support around participants. In other words, "no strings" does not mean "no services." Notably, GI recipients are *far more likely* to sign up for helpful resources when they are optional, meaning that *they* have the agency and dignity to choose what they need to help themselves and their families thrive. This finding provides compelling evidence that individual choice and agency matter and that people avail themselves of opportunities when aligned with their needs, goals, and capacities, an important learning for systems and their service provision.

Not only are supportive resources and referrals a best practice to enhance participants' self-sufficiency and connectedness, it also provides additional stability mechanisms that can help advance their goals long after the pilot ends. Moreover, many pilots offer proactive post-pilot support, connecting participants with continued services and resources, such as employment assistance, educational opportunities, and long-term housing programs and other benefits, to ensure they sustain the progress and gains made during the pilot. Our goal is to position Contra Costa's pilot participants to achieve lasting stability long after pilots conclude.

In addition, it is undeniable that people who stretch every dollar already know far better than most how to manage money; what they have often not had a chance to do is budget and save. GI is allowing participants and their children to make more pro-active and prudent financial decisions and investments for the first time.

Q: Why do we object to requiring GI pilot participants to be enrolled in one of the County's safety net programs?

A: We know from the data that many people who receive guaranteed income are enrolled in some form of benefits. But confirmed best practices in implementing GI programs tells us that their enrollment should not be a mandatory requirement. This conflicts directly with the bold and simple foundation of GI: give people cash, no strings attached. This is different than your legacy safety net programs, and this is evidence-based. Direct cash is reducing poverty and increasing financial resilience without the red tape, stigma, behavioral restrictions, and unreasonably low income limits that hinder government assistance programs. We are also mindful of these programs' built-in exclusions, which are conditioned on family status, immigration status, justice involvement, and, as previously mentioned, income limits that do not square with contemporary costs of living and basic needs realities.

While there are some pilots that use a pool of benefits recipients as the target population, they are far more rare. More often, percentages of Federal Poverty Level (FPL) that may align with certain public benefits thresholds are used as a cutoff for eligible applicants, or as part of a tiered approach to including different income levels into a single pilot. GI is part of a new era of creating policy pathways and support systems that are more responsive, realistic, and holistic and advance equity, justice, and collective well-being. GI programs elevate dignity, flexibility, agency, and trust. Minimal eligibility requirements or flexible verification of eligibility that request low time and administrative burden on the recipient to qualify are a key best practice. Further, whereas social safety net programs require that recipients meet continual eligibility requirements, GI programs require that participants meet upfront eligibility criteria after which they are eligible for the duration of the program. If we design the Contra Costa pilots as eighteen months, how are we accounting for a potential gap between eligibility for public benefits and GI, given that public benefits renewals do not follow an 18-month timeframe? Is it just at the start of the pilot that participants must be enrolled in public benefits, or must they stay throughout the duration? Again, procedurally and administratively, this will add to EHSD's administrative budget and workload.

Lastly, beyond administrative and programmatic barriers and exclusions, the low enrollment in public benefits programs showcased by Contra Costa's Employment and Human Services

Department is stark evidence of our residents' grave concerns with the system itself. Contrast that with the volume of eligible applicants who apply for guaranteed income pilot opportunities around the country, and it is clear that some of our current social safety net programs do not align with the needs, experiences, and goals of the populations they purport to serve. It is time to listen to community voice and to build public programs with public dollars that truly reflect the will and wisdom of the public they intend to serve.

Dear members of the Contra Costa County Board of Supervisors,

Bread for the City's Economic Security Team is writing this letter in support of the use of AB 109 excess funds for a guaranteed income pilot in Contra Costa County. Bread for the City<sup>1</sup> is a DC nonprofit whose mission for 50 years has been to help DC residents living with low income develop their power to determine the future of their own communities.

Our work with direct cash-giving accelerated in spring 2020. As Washington, DC shut down in response to the COVID-19 pandemic, Bread and three other partner nonprofits (BBAR, Martha's Table, and the Far Southeast Family Strengthening Collaborative) created a cash transfer program, THRIVE East of the River, for families who had experienced COVID-related job loss. When it was implemented, THRIVE was the largest privately-funded guaranteed income pilot ever created in the country and provided \$5,500 to over 600 households alongside other optional assistance like financial counseling, groceries, referrals, and assistance enrolling in benefits. An Urban Institute report<sup>2</sup> of the pilot revealed expected results - people used the money to pay for housing and food.

Since 2017, over 150 guaranteed income pilots have been implemented nationwide, including CashRx, our own pilot. What we continue to see, and can attest to from personal experience, is that the results from THRIVE East of the River are not unique. Participants of guaranteed income pilots are first and foremost securing food and housing. Beyond that, however, we are learning that cash-transfers are allowing families to truly thrive and dream.

One research finding that we find particularly compelling comes from a pilot run by our neighbors in Arlington, VA: "Arlington's Guarantee participants were significantly more likely than comparison group households to have set long-term goals<sup>3</sup> (84% participants, 53% comparison, 99% confidence)." The study also found that participants from both the treatment and control groups were equally likely to reach their long-term goals, teaching us that when people simply have the capacity to set goals, they will find a way to reach them.

At a CashRx check-in ten months into the pilot, we learned from one of our participants how the cash infusion has helped her control her diabetes. When the program started, our participant informed us of the measures she was currently taking for her condition - daily exercise and a diet that she maintained as much as possible, but her A1c hovered around 11. Over the course of the CashRx pilot, our participant's A1c lowered to 7.5, a remarkable improvement, which she attributes to the cash infusion. CashRx not only lowered her stress levels and improved her

mental health overall, having a positive impact on her A1c, but she was now able to purchase the fresh and healthy foods that she knew would improve her diabetes, foods that she previously did not have access to. This client's experience is one of many stories that showcase the positive impact that unrestricted cash can have on the unique experiences of individuals.

Our understanding is that the Board of Supervisors holds some concerns about participants' well-being after the conclusion of guaranteed income pilots, but the existing literature provides encouraging insights. The Arlington County pilot report found that at the end of the pilot, participants were more likely than the control group to have a higher household income (excluding pilot cash transfers) and higher paying jobs as well as increased employment. The report also explains that, because of the guaranteed incomes, families were better able to avoid increasing their debt when facing financial emergencies.

One of our CashRx participants had shared about her car troubles during her intake session. The car was too dangerous to drive, but she needed it for work. She was using public transportation in the meantime, but the lack of flexibility was forcing her to work less, impacting her income. After a few months of receiving CashRx transfers, the participant was able to pay to fix her car which she says she doesn't feel she would have been able to do otherwise.

It is stories like these that highlight the immeasurable impact that guaranteed income pilots have on the individuals and families that participate. Pilots like CashRx and the proposed Contra Costa pilot, while providing financial support that families desperately need, strengthen the evidence base for guaranteed income policies. In following the project outcomes of numerous guaranteed income projects implemented over the last several years, it is clear that direct cash giving works. Participants and their families are able to reach a basic income floor, experiencing reduced food and housing insecurity and increased mental and physical well being which in turn has a positive impact on communities as a whole. Recipients of guaranteed income programs, as the experts of their own lives, use program funds to meet their basic needs and as a basis for economic mobility and prosperity. The creation of each new pilot brings the hope of economic opportunity for those who need it most and fosters a path forward for more effective and transformative economic policy.

We, and our national partners in this work, understand where the narratives regarding guaranteed income come from and we urge PPC members and the Board of Supervisors to challenge them. Listen to the research findings, explore the why behind these harmful narratives, and join us in the understanding that they are based in fiction not fact. We also respectfully ask that Contra Costa's local decision makers and elected officials approach their responsibility with an empathic lens that takes into account what circumstances make their own situations the same and different from those whose lives their decision will impact.

Thank you for the opportunity to submit this letter. Your consideration of these matters and solutions is very much appreciated.
