## What is a MEHKO?



#### **Home-Based Restaurant**

Dine In, Pick Up, or Delivery

#### **Health Permit Required**

- Annual Routine Inspection
- Complaint Investigations
- Food Borne Illness Investigations

#### Small-scale (Updated 2023)

- 30 meals/day and 90 meals/week
- \$100K in gross annual sales

### **Examples of MEHKOs**













Tacos, Tamales, Dumplings, Pasta, BBQ, Hamburgers...

# **Community Benefits of MEHKOs**

- Increased economic opportunities
- Encourages safer and legal home businesses
- Allows people to learn small-scale food businesses
- Enables in-home care for families while still generating income
- Creates additional family income
- Provides food in remote locations and food deserts

### **Public Health Impacts** Cross-Contamination Risks

- No dedicated sinks or mechanical sanitation equipment
- No prohibition on non-food workers in kitchens
- No limitations on consumer access in facilities
- No limitations on the presence of animals in kitchens

# **MEHKO Programs in California**

#### **Fully Authorized MEHKOs**

- Riverside County (May 2019)
- Imperial County (January 2020)
- Lake County (January 2021)
- Alameda County (May 2021)\*
- Solano County (May 2021)\*
- Santa Barbara County (June 2021)
- City of Berkeley (July 2021)\*
- Sierra County (November 2021)

#### **Temporarily Authorized MEHKOs**

- San Mateo County (Sept. 2021-23)\*
- San Diego County (2022-23)
- Santa Clara County (March 2023)\*

#### **Formally Declined to Authorize MEHKOs**

- Siskiyou County (January 2019)
- San Joaquin County (March 2020)

\*Bay Area

### MEHKO Funding Budget Act of 2022

- \$5 million in competitive grants for non-profits
  - o Perform education & outreach
  - Negotiate rates
  - May provide direct support
- \*\$3 million for local health depts and city code enforcement
  - o Program development
  - Initial inspections
  - Enforcement activities

\*CCH is eligible for a portion of the funding




## **Discretion to Authorize**

The governing body (Contra Costa Board of Supervisors) has the authority to opt into or out of the MEHKO program for the entire county, including incorporated cities.

-- California Retail Food Code 114367
