Amendment No. 3 Summit Building Services, Inc. (May 1, 2021 thru April 30, 2025)

- 2. Section 4 (Payment Limit) of the Agreement is hereby amended by increasing the payment limit by \$800,000 from \$11,200,000 to a new payment limit of \$12,000,000.
