IN THE MATTER OF: Accepting completion of improvements for subdivision SD19-09527 for a project developed by Pulte Home Company, LLC, as recommended by the Public Works Director, Discovery Bay area. (District III)

WHEREAS the Public Works Director has notified this Board that the improvements in subdivision SD19-09527 have been completed as provided in the Subdivision Agreement with Pulte Home Company, LLC, heretofore approved by this Board in conjunction with the filing of the Subdivision Map.

WHEREAS, these improvements are approximately located near the eastern end of Point of Timber Road.

NOW, THEREFORE, BE IT RESOLVED that the improvements have been COMPLETED as of June 10, 2025, thereby establishing the six-month terminal period for the filing of liens in case of action under said Subdivision Agreement:

BE IT FURTHER RESOLVED that Wilde Drive, Point of Timber Road, Orwell Drive, Bradbury Drive, Bradbury Way, Bradbury Court, Milton Court, and Hemingway Lane for the hereinafter described public streets, as shown and dedicated for public use on the Final Map of subdivision SD19-09527 filed April 4, 2023, in Book 553 of final maps at Page 28, Official Records of Contra Costa County, State of California, are ACCEPTED AS COMPLETE
