

Second Amendment to Lease
Employment and Human Services Department
3105 Willow Pass Road
Bay Point, CA

This second amendment is dated December 31, 2025, and is between AMBROSE RECREATION AND PARK DISTRICT, a special district existing under the laws of the State of California (the “**District**”) and the COUNTY OF CONTRA COSTA, a political subdivision of the State of California (“**County**”).

Recitals

- A. The District and the County are parties to a lease dated February 25, 2014 (the “**Lease**”), under which the County is leasing a portion of the building located at 3105 Willow Pass Road in Bay Point that consists of approximately 5,193 square feet of floor space that is commonly known as classrooms 3, 7, 8, 9 and 10 (the “**Career Center**” or the “**Premises**”).
- B. The parties desire to extend the term of the Lease and revise the rent.

The parties therefore amend the Lease as follows:

Agreement

- 1. Section 3 of the Lease entitled “Term” is deleted in its entirety and replaced with the following:

Term. The “**Term**” of this lease is comprised of an Initial Term and, at County’s election, Renewal Terms, each as defined below.

- a. Initial Term. The “**Initial Term**” is 16 years, commencing on January 1, 2014 (the “**Commencement Date**”) and ending December 31, 2030.
- b. Renewal Terms. County has two options to renew this lease for a term of five years for each option (each, a “**Renewal Term**”) upon all the terms and conditions set forth herein.
 - i. County will provide District with written notice of its election to renew the Lease 30 days prior to the end of the Term. However, if County fails to provide such notice, its right to renew the Lease will not expire until fifteen working days after the County’s receipt of District’s written demand that County exercise or forfeit the option to renew.
 - ii. Upon commencement of a Renewal Term, all references to the Term of this Lease will be deemed to mean the Term as extended pursuant to this Section.

2. Section 4. of the Lease entitled “Rent” is deleted in its entirety and replaced with the following:

Rent. The County shall pay rent (“**Rent**”) to District monthly in advance beginning on the Commencement Date. Rent is payable on the 10th day of each month during the Initial Term and, if applicable, the Renewal Terms, in the amounts set forth below:

Rent for any partial month will be prorated and computed on a daily basis with each day's rent equal to 1/30 of the applicable monthly fractional rent.

3. All other terms of the Lease remain unchanged.
4. Counterparts. This second amendment may be executed in two or more counterparts, each of which shall be an original, but all of which together shall constitute one and the same agreement. Facsimile signatures or signatures scanned into .pdf (or in other electronic format) and sent by e-mail shall be deemed original signatures.
