First 5 Contra Costa has several contracts with county departments related to providing services and supports to families with young children. First 5 contracts with Contra Costa Health to match MHSA funding with First 5's funding to enhance the number of families who receive parent education classes and supports. First 5 is also a subcontractor for a mental health agency that receives funding from Contra Costa Health for home-based and wellness classes for families. First 5 Contra Costa also has two contracts with EHSD - one to support inclusion in child care and early learning settings, and another to augment concrete supports and fatherhood services delivered through three First 5 Centers in East County. In addition to these contracts, staff/elected officials from Contra Costa Health, EHSD and the Board of Supervisors serve on the First 5 Contra Costa Commission, and First 5 partners with several county departments to purchase administrative, IT, fiscal, facility, legal counsel and other services.
