

## Recap of June 24, 2025 Board Actions

---

1. Allocation: Indicated a desire to allocate \$1 million per District from the General Fund Appropriation for Contingencies for direction by each District Supervisor following a community engagement process
2. July 8, 2025 BOS Meeting: The County Administrator's Office should return to the Board on July 8, 2025 with information to assist the Board in making funding allocations to each District office for cost of conducting community outreach
3. August 5, 2025 BOS Meeting: The Board and the County Administrator should return to the August 5, 2025 Board meeting to report on the outcomes of the community engagement processes and make allocations.



# Community Engagement Funding Allocation Considerations

- Considerations for the Board is establishing community engagement allocations:
  - Rental Costs
  - Print Materials
  - Video Messaging
  - Website Survey
  - Translation
  - Interpretation (Simultaneous vs. Consecutive)
  - Staff time (if inviting Department staff)
- Depending how each individual Supervisor plans to conduct their Town Hall, estimate at least \$2,500-\$5,000

1. Some housing programs operated by Health Services, include food insecurity and rental assistance components.

2. Additionally, EHSD administers the CalFRESH program in which the State provides over \$244.9 million to eligible Contra Costa residents for food benefits.

## Highlights:

1. \$48.2 million allocated, with 90% of dollars in Contract
2. Of the Amount in Contract, 50.7% Expended with a Balance of 49.3%
3. The Board has made significant investments each program area with several millions of dollars remaining available.
