

AMENDMENT NO. 1 TO PARTICIPATING ADDENDUM
For
Purchases of Tires through State of California Contract No. 1-23-26-01B

This Amendment No. 1 ("Amendment") to the Participating Addendum, dated December 3, 2024, ("Agreement") is made and entered into as of January 7, 2026 ("Amendment Effective Date"), by and between Contra Costa County, a political subdivision of the State of California ("County"), and East Bay Tire Co., a California corporation (hereinafter referred to as "Contractor"), whose principal place of business is 2200 Huntington Drive, Suite C, Fairfield, CA 94533. The County and Contractor are sometimes referred to herein together as the "Parties," and each as a "Party."

Recitals

Whereas, Contractor offers tires under a statewide contract with the State of California, Contract No. 1-23-26-01B ("Master Contract") awarded by the State of California, Department of General Services and is made available to cities, counties, and other local agencies statewide.

Whereas, the County and the Contractor entered into the Agreement to allow the County to make purchases from the Contractor under the terms of the Master Contract. The Master Contract was set to expire January 6, 2026, and the Agreement was set to expire the same day.

Whereas, on April 16, 2025, the term of the Master Contract was extended by one year, through January 6, 2027, and the Parties desire to extend the term of the Agreement by the same amount of time.

Amendment

NOW, THEREFORE, for good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Contractor and the County agree to amend the Agreement, as follows:

1. Term. Section 1 (Term) of the Agreement is deleted in its entirety and replaced with new Section 1, to read:

"1. Term. The term of this Agreement begins on the Effective Date, and it expires on January 6, 2027. If the term of the Master Contract is extended, the County and the Contractor may agree to extend this Agreement by up to the same amount of time. Any extension of the term of this Agreement is subject to the prior approval of the County's Board of Supervisors, its governing body. If the Master Contract is terminated prior to the expiration of the term of this Agreement, the Contractor shall continue to perform under this Agreement until the term of this Agreement expires."

2. Remainder Unchanged. Except to the extent that the Agreement is expressly modified by this Amendment, the remainder of the Agreement remains unchanged and in full force and effect.
