





County-Wide Service Map





I.	Child Health and Safety: Reduce or eliminate children's risk of exposure to harm and hazards.	 Continue to implement daily, weekly, monthly, and quarterly monitoring to identify and remove environmental harm and hazards.
II.	Partnerships with State Systems: Expand Head Start programs' capacity to coordinate services with state systems and national programs.	 Use state funding to extend hours to support commuting parents working varied shifts. Maximize receipt of state funding by matching more than the required 20%
III.	Reaching Children and Families: Ensuring that Head Start resources are targeted to children, families, and communities of greatest need.	 Distribute slots equitably throughout the county based on economic need. Increase the number of slots to serve closer to 100% of eligible children and families. Shift slots from Head Start to Early Head Start given that California public schools now offer free Transitional Kindergarter for children age 4
IV.	Investing in the Workforce : Supporting a highly- skilled workforce with competitive pay, benefits, and access to supports for staff wellness.	 Attempt to achieve parity with local school district pre-school teacher salaries by increasing salaries for county employees and increasing rates for partners.
IV.	Quality Environments: Strengthening the key components of infrastructure that assist Head Start programs with operating most effectively.	• Expand mental health for children and families.



Subject: Resolution of the Board of Supervisors Establishing the Formal Governance Structure for the Contra Costa County Head Start Program

Information: Establishes the formal structure of program governance for the Contra Costa County Head Start program, including the oversight of quality services for children and families and procedures for making decisions related to program design and implementation. Outlines the roles for the Board of Supervisors (Governing Body), Head Start Oversight Committee, EHSD Director (Head Start Executive Director), and Policy Council.

Head Start Policy Council

Structure:

- Elected by parents of children currently enrolled in the Program, composed by parents and members at large of the community served
- Responsible for the direction of the Program

Submits to the Board decisions about:

- Activities to support active involvement of parents
- Program recruitment, selection and enrollment priorities
- Applications for funding and amendments
- Budget planning for program expenditures
- Policy Council bylaws
- Program personnel policies
- Procedures for how Policy Council members are elected
- Recommendations on selection of delegate agencies

Information: Establishes the formal process for documenting and resolving complaints involving the Head Start program and complaints involving the Director or Executive Director of the Head Start program.





Board Resolution No. 2023/499

Adopted: July 13, 2023

Subject: Resolution of the Board of Supervisors Establishing the Internal Controls that Apply to Contra Costa County Head Start Program Funds, Assets, and Equipment

Information: Identifies the County's fiscal accountability rules, policies, and procedures under which the program operates. Establishes the fiscal monitoring roles and responsibilities for the Governing Board (Board of Supervisors), the Head Start Oversight Committee, and staff.

Role of Head Start Oversight Committee

Structure:

- 2 Board members appointed annually by the Board who meet every other month
- Make recommendations to the Board on key responsibilities related to program governance and improvement of the Head Start Program

Fiscal Monitoring:

- Detailed program financial statements of expenditures at object level (i.e., Salaries and Benefits, Services and Supplies, Other Charges, Fixed Assets, and Expenditure Transfers) and revenue by major federal and state grant type
- Details of self-monitoring activities by staff, including schedules for planned monitoring activities, updates of ongoing monitoring activities, final results of monitoring activities and status of internal monitoring of corrective action plans
- Details of staff fiscal trainings, including copies of training agendas, materials, and employee attendance as well as listing of how many employees have not received training and plan for when those employees are to receive training
