Furthermore, I initiated a program to support students dealing with sexual harassment, with a budget of 2.1 million dollars. I have also been involved in various college clubs, where I helped students amplify their voices, build confidence, and secure scholarships to pursue their goals. Even today, I continue to volunteer my time to support deserving candidates for election, as I believe in the importance of having leaders who will bring positive changes to our community. Having experienced poverty firsthand, I am committed to never ceasing my efforts to help those in need, as I understand the struggles and firmly believe that everyone deserves access to basic necessities.
