

AMENDMENT NO. 1 TO THE PARTICIPATING ADDENDUM
for
Public Utility Equipment and Related Products and Services

Participating Entity:
CONTRA COSTA COUNTY

Contractor: Altec Industries, Inc. (Contract No. 110421-ALT)

This Amendment No. 1 (“Amendment”) to the Participating Addendum, dated March 25, 2025 (“Agreement”), is made and entered into as of November 18, 2025 (“Effective Date”), by and between Contra Costa County, a political subdivision of the State of California, (“County”) and Altec Industries, Inc., an Alabama corporation (“Contractor”). The County and the Contractor are sometimes referred to herein together as the “Parties,” and each as a “Party.”

Recitals

Whereas, the Contractor sells public utility equipment and related products and ancillary services under a cooperative purchasing agreement, identified as Contract No. 110421-ALT (“Master Contract”), awarded by Sourcewell, a State of Minnesota public agency, following a competitive solicitation.

Whereas, the County and the Contractor entered into the Agreement to incorporate the terms of the Master Contract, allowing the County to make purchases from the Contractor pursuant to the Master Contract, subject to the terms of the Agreement.

Whereas, the Agreement and the Master Contract were both set to expire on December 27, 2025, but the Agreement provides that its term may be extended provided that the term of the Master Contract is extended by at least the same amount of time.

Whereas, Sourcewell and the Contractor executed a Contract Extension, a copy of which is attached hereto, to extend the term of the Master Contract through December 27, 2026, and, therefore, the Parties desire to extend the term of the Agreement by the same amount of time.

Amendment

Now, therefore, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the County and the Contractor agree, as follows:

1. Recital Correction. The first recital of the Agreement is modified by deleting “032824-PMC” and replacing it with “110421-ALT” to reflect the correct Sourcewell contract number.
2. Term. Section 1 (“Term”) of the Agreement is amended to read, as follows:

“1. Term. The term of this Agreement begins on the Effective Date, and it expires on December 27, 2026, unless sooner terminated as provided herein. The Parties may agree to extend the term of this Agreement, provided that the Master Contract is extended by at least the same amount of time. If the Master Contract is terminated prior to the expiration of the term of this Agreement, the Contractor shall continue to perform under this Agreement until the term of this Agreement expires, or until this Agreement is terminated, whichever occurs first.”

3. Remainder Unchanged. Except to the extent the Agreement is modified by this Amendment, the Agreement remains unchanged and in full force and effect.
