### TRAFFIC RESOLUTION NO. 2024/4542 Supervisory District V

**SUBJECT:** ADOPT Traffic Resolution No. 2024/4542 for an 18-month extension of the temporary closure of South Broadway Avenue (Road No. 5385BA) between the city limits of Pittsburg and extending northerly to Maylard Street (Road No. 5385AX), to prevent serious and ongoing criminal activity, Bay Point area.

WHEREAS, the portion of South Broadway Avenue, which begins at the city limits of Pittsburg and extends northerly to Maylard Street, and has experienced serious and continual illegal dumping and serious and continual criminal activity, leading to the prior closure of the roadway;

WHEREAS, the current closure approved by the Board of Supervisors on June 27, 2023, extends through December 27, 2024, when it will expire if not extended;

WHEREAS, the Public Works Department has requested the closure of the portion of South Broadway Avenue to prevent the occurrence or recurrence of serious and continual illegal dumping and serious and continual criminal activity;

WHEREAS, because allowing vehicle traffic on the roadway will result in the occurrence or recurrence of that illegal dumping and criminal activity, the County Office of the Sheriff and California Highway Patrol, and Public Works Department staff, all recommend the continued closure of this portion of South Broadway Avenue for an additional 18 months;

WHEREAS, Public Works Department staff determined that: South Broadway Avenue has not been designated as a through highway or arterial street; the closure of South Broadway Avenue will not impact traffic flow, safety on the adjacent streets or in the surrounding neighborhoods, the operation of emergency vehicles, the performance of municipal or public utility services to, or the delivery of freight by commercial vehicles in the area of South Broadway Avenue; and

WHEREAS, a public hearing has been held on this proposed closure of South Broadway Avenue, notice of which was mailed to the residents and owners, as shown on the last equalized assessment roll, of property adjacent to that portion of roadway, in accordance with Vehicle Code section 21101.4(c).

NOW, THEREFORE, BE IT RESOLVED THAT, pursuant to Vehicle Code section 21101.4, subdivision (b), by the Board of Supervisors of the County of Contra Costa, as follows:

1. The Board of Supervisors FINDS as follows:

A. Based on the recommendation of the County Office of the Sheriff and California Highway Patrol, continuation of the temporary closure of South Broadway

Avenue (Road No. 5385BA), between the city limits of Pittsburg and extending northerly to Maylard Street (Road No. 5385AX) for an additional 18 months will prevent the occurrence or recurrence of the serious and continual illegal dumping. The above-described section of South Broadway Avenue is not designated as a through highway or arterial street;

- B. Vehicle traffic contributes to the above-described illegal dumping and criminal activity on the above-described section of South Broadway Avenue;
  - C. The immediately preceding closure (i.e., the current closure that commenced June 27, 2022) of the above-described section of South Broadway Avenue has not substantially adversely affected traffic flow, safety on the adjacent streets or in the surrounding neighborhoods, the operation of emergency vehicles, the performance of municipal or public utility services to, or the delivery of freight by commercial vehicles in the area of, that section of roadway.
2. The Board of Supervisors ADOPTS this Traffic Resolution No. 2024/4542 for an extension of the temporary closure of South Broadway Avenue, between the city limits of Pittsburg and northerly to Maylard Street, beginning December 27, 2024, and continuing for 18 months thereafter.
