STATEMENT:

My name is Marlene Lerner-Bigley and I am a 49 year resident of Martinez. I was born and raised in Lenoir, NC as the daughter of two parents who were victims of the Holocaust. My father came from Poland in 1938 and my mother came from Germany in 1939. They each were escaping Nazism. My dad wanted to give back to the country that saved his life, so he enlisted in the Army in hopes of being sent back to Europe. The Army sent him to the Pacific Theater where he became a Staff Sgt. and he learned how to speak better English. My mother and her two siblings ended up in New York City where my uncle also enlisted in the Army. My mother and her sister worked 3 jobs to make ends meet. My mother met my dad through a girlfriend who she worked with and 6 weeks later, they married. That was in 1946. Fast forward to 1987, when the Berlin Wall came down, my uncle, who lived in England, flew to Berlin to find out the fate of his parents. Sadly, he learned that my grandparents had been taken from their home and put into a work camp. From there, they were transported to a camp deep in the forest in Poland. The camp was called Chelmno and was a gas camp. In January of 1942, Isaac and Martha Teich-Birken were gassed along with 9 others, in a van. And for what reason, other than they were Jewish??

Recently, I found out from the German consulate in SF, that my mother's passport was a "foreigner's" passport and that the Nazis deemed her stateless and a non-citizen. Imagine my surprise and at that moment, I realized her despair. The impact of being separated from her precious mother and father was devastating when she left them, and then again, when she found out how they died.

This story must sound familiar to you as to what is going on with the regime that is in The People's House. The Latino/Latina community desperately needs our help and our backing,

your backing! Please have the courage to enact an absolute securely tight Ordinance that restricts the Contra Costa County Sheriff's Dept from providing ICE with information on immigrants who work hard, who have been here for a long time, who live amongst us. This is a violation of the privacy act and this community, ALL of us, deserve that support.

QUESTIONS:

Will you take the pledge to protect our familia by creating a steadfast, clearly-stated comprehensive and <u>permanent</u> ordinance that prohibits Contra Costa County law enforcement agencies from cooperating in deportations with ICE? Will you pledge to require to order full transparency to the family members of the person detained and why?

Thank you for your time and I hope I am chosen to read my statement.
