- At December meeting, before voting occurs, candidates will be asked to speak for up to 2 mins about why they want to be an officer and what they plan to do in that position.
  - > Membership Committee: Jill Kleiner
    - Susan Wright is recommended to the Board of Supervisors.
    - San Ramon and San Pablo seats still open.
    - One person on wait list for an at large/alternate seat.
    - Two candidates will be interviewed in October.
  - > Planning Committee: Jill Kleiner
    - Choice in Aging tours set for Oct 22 and Oct 30.
  - > Housing Committee: Kevin Donovan
- Assembly Member Wicks put together a series of 22 bills to streamline the process of Affordable Housing approval called the "The Fast Track Housing Package". The Housing Committee asks the Executive Committee to approve a letter (insert attachment) in support of the package. The letter will be sent to 4 State Assembly Members and 3 State Senators.
