Project Description: The Contra Costa County Public Works Department (County) intends to install approximately four speed humps along the entirety of Loftus Road. Existing pavement will be cut and ground down to install the hot asphalt mix speed humps and new traffic striping. Permanent traffic signs will be installed for each speed bump. The project will require temporary traffic control which will last for approximately ten days. Emergency vehicles will have access at all times.

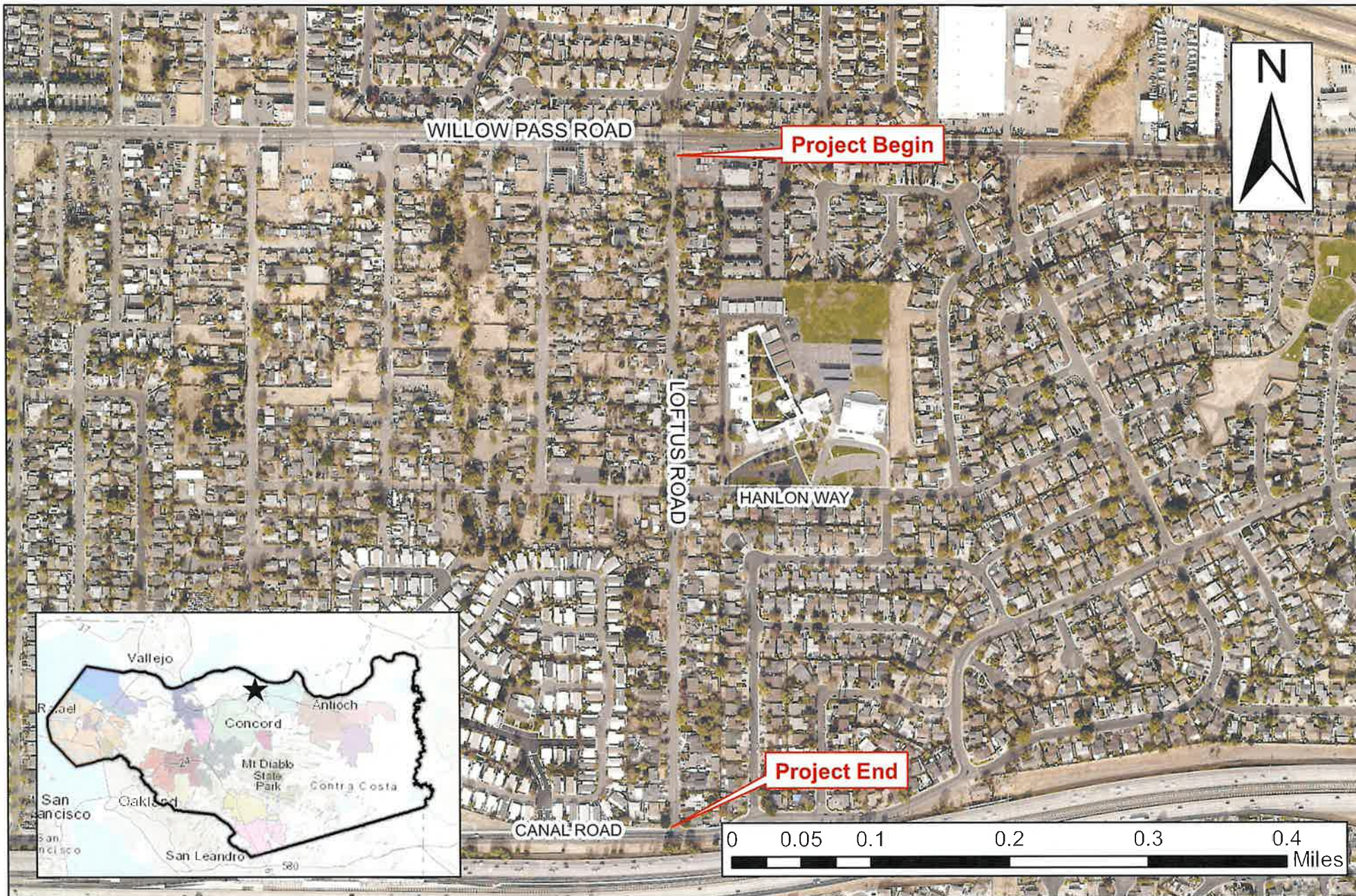
PROJECT LOCATION MAP
