AMENDMENT SPECIFICATIONS

Due to Agency's need for additional Contractor's services, for good and valuable consideration, in exchange for the mutual promises set forth in this Amendment No. 1, County and Contractor hereby amend the Contract as follows:

I. Section b. of Item 1 Parties of the agreement is hereby amended by deleteing "11720 Plaza America Dr. Reson, VA 20190" as the address therefrom and replacing it with "5201 Congress Avenue Suite 220, Boca Raton, FL 33487".

II. Appendix B (Payment Provisions) of the Agreement is deleted in its entirety and replaced with Appendix B (Payment Provisions 2025) attached hereto and incorporated herein.

III. Section e. of Paragraph II of Appendix F (Deliverables) is hereby amended by deleting "Restoration" therefrom and replacing it with "Registration."

IV. Paragraph II of Appendix F (Deliverables) is herby amended by adding section f. immediately after section e. as follows:

- f. Blackboard Registration and Management Implementation team will enable and provide the Video Studio tool for County staff to utilize to record and share videos within the Blackboard Learn platform. The Video Studio tool will:
 - i. Help County staff record and share videos within the Blackboard Learn platform
 - ii. Include unlimited video storage capacity

III. Invoice Payment Terms.

A. Contractor agrees to the payment terms set forth in this Appendix B and the Agreement.

B. Contractor will submit a County Demand form D-15, accompanied by documentation of expenditures and services hours, to County's Authorized Representative for authorization of payment. Contractor will submit demands for payment no later than 30 days from the end of the month in which the contract services upon which such demand is based were rendered. Upon approval of payment demands by County's Authorized Representative, County will make payments within 30 days of invoice.

C. Adjustments between line-item expenses may be made if the line-item budget adjustment is ten percent or less of the budgeted line item. The County's Authorized Representative may approve any line-item adjustment which exceeds the line-item budget by more than ten percent.
