Resolution Terminating and Abandoning
an Offer of Dedication

ABSTAIN:

(Gov. Code 66477.2 (c))

SUBJECT: **ADOPT** Resolution No. 2025/** terminating and abandoning an Offer of Dedication for storm drain easement of 1131 Douglas Court, Alamo Area, District II. Project No.: 0676-6Q1833

WHEREAS, in 1979, Contra Costa County (County) received, but did not accept, an offer of dedication for storm, flood and surface water drainage of Douglas Court. The offer of dedication was included on the approved Subdivision MS 54-77 book 75 page 5.

WHEREAS, the storm drain easement identified as 1131 Douglas Court described in Exhibits A and B and shown as Exhibits A1 and B1 attached hereto was not accepted, and it has been determined that the right of way is not needed for any current or future County drainage purposes.

WHEREAS, the current owners of APN 192-220-015 have requested that the County terminate and abandon the offer of dedication.

WHEREAS, this Termination of an Offer of Dedication of a certain excess right of way is made pursuant to Government Code 66477.2 subdivision (c) and to Part 3 of Division 9, Chapter 4 of the Streets and Highways Code, commencing with Section 8333(a), et. seq.

WHEREAS, the Offer of Dedication is more particularly described in Exhibits "A" and "A-1" and Exhibits "B" and "B-1", attached hereto and incorporated herein.

WHEREAS, Public Works Department staff has determined there is no possibility that terminating and abandoning the offer of dedication may have a significant adverse effect on the environment.

WHEREAS, there are no known public facilities within the easement area.

NOW, THEREFORE, IT IS RESOLVED by the Board of Supervisors of Contra Costa County that:

RESOLUTION NO. 2025/_____

The Board FINDS that there is no reasonable probability that the offer of dedication will be accepted into the County's drainage system, which the County has not expended County funds to maintain or improve the easement, and it is in the best interest of the County and the public that the easement be terminated.

The Board FINDS that terminating and abandoning the offer of dedication of the drainage easement will not have a significant effect on the environment and is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Article 5, section 15061(b)(3).

The offer of dedication described and depicted in Exhibit "A" and "A-1" is hereby TERMINATED and ABANDONED pursuant to Government Code section 66477.2 subdivision (c), and to Part 3 of Division 9, Chapter 4 of the Streets and Highways Code, commencing with section 8333(a), et, seq.

The Board DIRECTS the Public Works Director to cause a certified copy of this Resolution to be recorded in the Office of the County Clerk-Recorder.

From and after the date this Resolution is recorded, the Offer of Dedication described in Exhibit "A" and "A-1" is terminated and the County's right to accept the offer is abandoned.
