Applications are the starting point of any process for a county job. Each application is reviewed by an HR staff member to see if minimum qualifications are met based on demonstrations of skills, instead of keywords or buzz words. A 5-day rebuttal period is granted if an application is rejected based on minimum qualifications.

Plans for more community outreach through ORESJ partnership, trainings on pathways from entry level to higher paid positions, more training opportunities to current employees and prospective employees, and learning how processes overall can be improved.
