

**AMENDMENT NO. 3 TO
PARTICIPATING AGREEMENT
FOR
MAILING EQUIPMENT, SUPPLIES, AND MAINTENANCE**

Participating Entity:
CONTRA COSTA COUNTY

Contractor: Quadient, Inc.

This Amendment No. 3 (“Amendment”) is entered into as of May 14, 2026 (“Amendment Effective Date”), by and among Contra Costa County, a political subdivision of the State of California (“County”), Contra Costa County Fire Protection District, a fire protection district formed under the Fire Protection District Law of 1987 (“District”), Quadient, Inc., a Delaware corporation (“Contractor”), whose principal place of business is 478 Wheelers Farms Rd., Milford, CT 06461, and Quadient Leasing USA, Inc., a California corporation (“Lessor”), whose principal place of business is 478 Wheelers Farms Rd., Milford, CT 06461, to modify the Participating Agreement, dated May 19, 2026, as amended (“Agreement”), by and among the County, the District, the Contractor, and the Lessor. The County, the District, the Contractor, and the Lessor are sometimes referred to herein together as the “Parties,” and each individually as a “Party.” Terms used but not defined in this Amendment shall have the same meanings as the terms have in the Agreement, as amended.

Recitals

Whereas, the County, the District, the Contractor, and Lessor entered into the Agreement to allow the County and District to purchase mailing equipment and related supplies and maintenance under the State Addendum, which incorporates the terms of the Master Contract. The Agreement also allows the County and District to lease and rent certain products and equipment under Lessor’s Government Product Lease Agreement, Postage Meter Rental Agreement, Postage Funding Account Agreement, Maintenance Agreement, and Online Services and Software Agreement, subject to the modifications to those agreements set forth in the Agreement.

Whereas, the term of the State Addendum had been set to expire May 14, 2026, before the State and the Contractor agreed to extend the term through May 14, 2027. The Parties now desire to extend the term of the Agreement by the same amount of time.

Amendment

Now, therefore, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the County, the District, the Contractor, and the Lessor agree to amend the Agreement, as previously amended, as follows:

1. Term. Section 1 (Term) of the Agreement is deleted and replaced with new Section 1, to read:

“1. Term. The term of this Agreement begins on the Effective Date, and it expires on May 14, 2027. The Parties may amend this Agreement to extend the term beyond May 14, 2027, provided that the State Addendum is extended for at least the same length of time. If the State Addendum is terminated prior to the expiration of its term, or any extension thereof, Contractor shall continue to satisfy its obligations under this Agreement (which incorporates the terms of the State Addendum) until this Agreement expires or is terminated.”

2. Remainder Unchanged. Except to the extent that this Amendment expressly modifies the Agreement, the remainder of the Agreement remains unchanged and in full force and effect.
