Our office has reviewed your bid submission, and we have determined that your firm's bid was incomplete and unsigned, in that you failed to complete, sign, and submit page 10 of the bid form (Signature of Bidder). As stated in the project specifications, failure to submit the forms and information as specified may result in a nonresponsive bid and, to qualify for contract award, the Bidder must comply with all requirements prescribed in the call for bids (see Sections 2-1.33A and 3-1.04). Since your firm submitted an incomplete and unsigned bid form and did not comply with all the requirements in the call for bids, we plan to recommend that your firm's bid be rejected as non-responsive.

Should your firm disagree with our determination, you may appeal it in writing to the Public Works Director at 255 Glacier Drive, Martinez, CA 94553 (see Section 2-1.12A(6)). Your firm's appeal must be received at that address no later than 5:00 p.m. on June 22, 2026, and must describe in detail all facts and arguments on which your firm relies.

It is anticipated that the Board of Supervisors will award contracts to the lowest responsible bidders, Sky Rock Inc, U.S.A. Trucking Inc., 4 Brothers Trucking LLC, and Mitchells Transport LLC, who have complied with the contract requirements, at the Board meeting on July 7, 2026, which begins at 9:00 a.m.
