- 2. RECEIVE and DISCUSS the applications for the Transitional Community Advisory Body for the African American Holistic Wellness and Resource Hub and DETERMINE the next steps of the application process.
 - a. Supervisors to select the top 20 applicants based on Supervisor/District-based recommendations, diversity of lived experience navigating systems (priority areas), and gender balance (to ensure Black males are represented on the TCAB).
 - b. ORESJ will invite finalists to the Oct 6th meeting to be interviewed.

Supervisor Carlson gave an overview of the TCAB purpose. The role of TCAB is to guide selection criteria to establish a board of directors and executive director for the Hub. Conflict of interest is to be avoided.

Kendra Carr, ORESJ Co-director, thanked the Supervisor for remarks and reminders. Kendra gave recap that from the last Equity meeting, ORESJ staff were directed to reach out to Supervisors regarding applications received from their district. One additional District 2 application received. There are now 49 applications for 13 seats. Kendra thanked the community for their interest and gave reminder that TCAB meetings are open to the public. If not selected, please participate in the public meetings.

Kendra will share a chart with the Supervisors selections (see below).

Supervisor Scales-Preston suggested that the District 2 application period remain open to allow for additional applicants. Supervisor Carlson stated that he added one "out of town" applicant to be interviewed – this person works in District 4. He also expressed support for keeping District 2 application period open while TCAB interviews move forward. Supervisor Scales-Preston expressed desire for process transparency, as well as having each district represented on the committee. Supervisor Carlson agreed.

Kendra Carr pulled up recommendations from each Supervisor of applicants selected to move forward for interviews (see chart below).

Kendra Carr: Review panelists will be asked to recuse themselves if they have a personal relationship with the eventual Hub applicant.

Yvette Williams: Transparency. Define personal relationships.

Supervisor Carlson: More than an acquaintance. Will your relationship with that person bias you in the decision-making process. EX: family, co-worker

Kendra Carr: An ambassador or staff of a particular agency that may apply to be the Hub administrator. Financial partner relationship. If so, that is a conflict and they are asked not to apply. This process should be done with integrity and fidelity. Build trust in community.

Jessica: Beautiful committee. Lifts up with Kendra said about want to widen community and continue to build partnerships. Amazing applicants. Encourage continued engagement. We want to widen, deepen and weave our relationships around this work.

Kendra Carr: Jessica will facilitate TCAB.

Supervisor Carlson: Express gratitude for all 49 applicants.

Supervisor Scales-Preston: Echo same sentiment. Hope that individuals will apply to other BOS committees
