#### PRELIMINARY LANDSCAPE ANALYSIS: KEY ISSUES FOR AFRICAN AMERICAN COMMUNITIES

 Based on secondary data, here are some key challenges facing African American communities in Contra Costa County. We based this inquiry on the KPI's established in the last meeting and cross-referenced it with existing ORESJ data from February 2022.

6	African American Males	African American males disproportionately affected by heart disease and diabetes, 23% report mental health conditions (https://www.chis.ucla.edu)	33% harmed by health services, 35% harmed by mental health, 37% harmed by education, 50% harmed by racial violence, 41% harmed by employment services, 41% harmed by police violence, 25% harmed by government violence
7	Mental Health and Substance Use Support	23% report mental health conditions, but only 14% report receiving treatment (https://www.chis.ucla.edu)	34% harmed by health services, 33% harmed by mental health, 52% harmed by police violence, 55% harmed by racial violence, 37% harmed by homophobic and transphobic violence

- What additional questions should we include to address the wellness challenges of these groups?


#### ENGAGING THE STEERING COMMITTEE: ROLES AND CONTRIBUTIONS

- We invite committee members to actively contribute to the listening sessions by taking on any of the following roles:
  - **Outreach**: Help spread the word about the listening sessions by reaching out to your networks, organizations, or community groups to encourage participation.
  - **Facilitation**: Act as a session facilitator by guiding discussions, making sure that all voices are heard, and keeping the conversation on track.
  - **Note-taking**: Volunteer to document insights, questions, and concerns raised during the sessions, which will be invaluable for our final analysis.
  - **Logistics**: Assist with event setup, including securing venues, arranging virtual platforms, or ensuring that participants have necessary materials or resources.
  - **Follow-up and Engagement**: After sessions, help with follow-up tasks, such as sending summaries to participants, gathering additional feedback, or organizing the next steps.
  - **Feedback on Protocol**: Provide input on the revised listening session protocol, helping to refine questions and approaches to better meet the needs of target populations.

1	Personal Wellness Definition	How do you define wellness for yourself and your community, including mind, body, spirit, and environment? What does it mean for you to feel well?
2	Culturally Competent Care	What does culturally competent care look like for you? What practices would make you feel that the care provided is respectful and effective for your wellness needs?
з	Culturally Relevant Services	What services or healing practices do you feel are missing for the Black community in Contra Costa County? How important is it for these services to reflect your cultural values and traditions?
4	Barriers to Access	What are the main barriers preventing Black community members from accessing wellness resources (e.g., transportation, awareness, affordability)?
5	Spaces and Events for Healing	Can you describe any spaces or events that have helped you or others heal from trauma or injustice? How can we create similar spaces at the Wellness Hub?
6	Services at the Wellness Hub	What specific services and wellness practices (e.g., mental health care, alternative medicine, financial support) would you like to see offered at the Wellness Hub? Who should be prioritized in receiving these services?
7	Community Healing	How important is collective healing for your community's wellness? What role should the Wellness Hub play in cultivating a space for community healing and connection?
8	Creating Safe and Welcoming Spaces	What should the Wellness Hub do to ensure people feel safe, respected, and welcome when they come for services?
9	Vision for the Future	What does a healthy, thriving African American community in Contra Costa County look like to you? What key outcomes would you like to see from the Wellness Hub in the next five years?
