Resolution No. 2025-183

IN THE MATTER OF Completion of the 2023 Countywide Surface Treatment Project, (County Project No. 0672-6U2112) Bay Point, Pacheco, Contra Costa Centre, and Kirker Pass areas

The Board of Supervisors **RESOLVES** that:

WHEREAS,

Contra Costa County on June 13, 2023 contracted with Northwest Paving, Inc. for the above project generally consisting of surface treatment work in the unincorporated Bay Point, Pacheco, Contra Costa Centre, and Kirker Pass areas. Work in Bay Point (Site 1) included applying either an asphalt rubber chip seal covered with a type II slurry seal or applying a type II slurry seal only on various roads. Work in the Pacheco Area (Site 2) included placing asphalt rubber chip seal covered with a type II slurry seal. Work in the unincorporated area of Contra Costa Centre (Site 3) included applying a micro-surfacing on various roads. Work on Kirker Pass Road (Site 4) included placing a micro-surfacing on a portion within the unincorporated area of Concord and a portion within the city of Pittsburg limits. Work in all areas also included pavement surface preparation including: weed spray, crack sealing, edge grinding, and pavement markings including thermoplastic stripe removal; adjusting and setting survey monuments, placement of thermoplastic traffic striping and pavement markings, all in accordance with the plans, drawings, special provisions and/or specifications prepared by or for the Public Works Director and in accordance with the accepted bid proposal. The project was located in the Bay Point, Pacheco, Contra Costa Centre, and Kirker Pass areas, with the Everest Reinsurance Company, as surety, for work to be performed on the grounds of the County; and

WHEREAS, the Public Works Director reports that said work has been inspected and complies with the approved plans, special provisions and standard specifications and recommends its acceptance as complete as of December 16, 2024.

NOW, THEREFORE, BE IT RESOLVED that this project is accepted as complete as recommended and that the Public Works Director, or designee, shall file the attached Notice of Completion together with a certified copy of this Resolution with the County Recorder no later than 15 days after the adoption of this Resolution pursuant to Civil Code Section 9204.

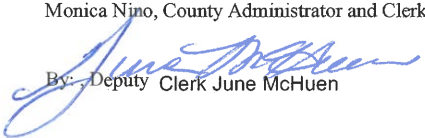
