Dear Supervisors,

On behalf of *Ensuring Opportunity* and the *Contra Costa Budget Justice Coalition*, we are writing to urge the Board of Supervisors to expand tomorrow's funding allocations to address **both food security and other critical community needs**.

While we appreciate the County's commitment to supporting residents who will lose their CalFresh benefits this month, we are deeply concerned that unless tomorrow's proposal (Item D.2) is significantly modified, the Board risks creating a troubling disconnect between EHSD's CalFresh backfill proposal and the recently completed, long-awaited ARPA community input process.

Over the past several months, you have heard directly from hundreds of residents and organizations across Contra Costa County about their most pressing needs, with food insecurity being amongst the most urgent. Yet the current proposal would allocate all remaining ARPA funds to a single program—CalFresh, while excluding thousands of immigrants and other residents who are not enrolled in CalFresh but will still experience hunger. This single-focus approach would also overlook urgent community needs such as **rental assistance, youth programs, and mental health supports**—all clearly identified as top priorities in the ARPA town halls and countywide needs survey.

We ask the Board to consider the following:

1. **Allocate \$21 million from the County's \$500 million in excess General Fund reserves** to cover the November CalFresh backfill;

2. **Use a portion of the remaining ARPA funds** to support food banks and other community-based food security programs serving residents who are not eligible for CalFresh but are facing immediate hardship; and
  
3. **Invest the remaining approximately \$17 million in ARPA funds** in rental assistance, youth services, mental health, and other community priorities identified through the ARPA engagement process. *(The Budget Justice Coalition will soon release its analysis of the top needs identified at the community town halls.)*

While EHSD’s proposal is a good first step, it does not reflect the full scope of community food insecurity and safety net needs, nor does it honor the extensive public input gathered over the past few months. We urge the Board to consider the entire ecosystem of need—not just one program. That would be the most equitable approach, especially in a time when many Black residents remain disconnected from County systems, a growing number of seniors are becoming unhoused, and many immigrant families live in fear and deprivation.

Finally, County leaders and staff have worked hard—during and after the pandemic and in the wake of the national racial reckoning to build deeper trust with the community. If the Board chooses to disregard the input shared through town halls, county surveys, and Measure X discussions by directing all ARPA funds toward a single County program for one month, it risks undoing that trust and deepening community cynicism toward County leadership.

We urge you to honor the community’s input and act in alignment with the County’s equity commitments. Please use reserve funds to backfill CalFresh and dedicate ARPA dollars to the broader set of urgent community priorities identified by residents and trusted organizations.
