ATTENDANCE/REPRESENTATION

The 14-member Commission has members and alternates from organized labor, environmental groups, an Environmental Justice community, industry, cities, environmental engineering firms, the League of Women Voters and the public at large. The Commission held 10 full Commission meetings this year. The Commission meetings averaged 9.4 commissioners or their alternates per meeting.

No training or certification was provided or conducted.

PROPOSED WORK PLAN/OBJECTIVES FOR THIS YEAR

In 2024 the Commission will continue to investigate some of the issues they began investigating in 2023 and will address emerging issues that are brought to them by the Board of Supervisors, the public and members of the Commission. In addition, the Commission will continue to monitor several issues that they monitored in 2023.

The issues the Commission intends to work on in 2024 that were carried over from 2023 are the update to the County's General Plan, review of the AB 617 Community Emissions Reduction Plan for the Richmond/San Pablo area, review of the DTSC Hazardous Wates Management Plan and local hazardous waste management, the Northern Waterfront Economic Development Initiative's efforts to clean-up brownfield sites within its border, brownfield community engagement and signage, and hazardous materials-related State legislation.

New issues the Commission will address in 2024 will be carbon sequestration and Community Warning System Level 1 notifications.

Issues the Commission will continue to monitor are the implementation of the County's Pharmaceutical Ordinance, the operation of the Community Warning System, the implementation of the County's Industrial Safety Ordinance and Emergency Notification Policy, PFAS regulation, the impacts of sea level rise on hazardous materials and wetlands, and refinery conversion to biofuels.
